1. MINUTES

The Minutes of the meeting held on 30 June 2016 were agreed as a correct record.

2. MATTERS ARISING FROM THE MINUTES

Further to Minute 8 of the previous meeting, the Group had been on a tour of the town centre prior to the meeting and Councillor R Williams confirmed that she would circulate a separate list of observations prior to the next meeting.

Further to Minute 2 of the previous meeting, Alan Fleming reported that the toilets in the Broad Street Mall were working.

Further to Minute 4 of the previous meeting, Alan Fleming reported that he had met with representatives from GWR who had confirmed that Changing Places would be provided on the north side of the station when Crossrail came to Reading in 2019.

It was reported that over-hanging branches were an issue on footways, particularly for blind people, and it was suggested that this could be reported through Neighbourhood Action Groups (NAGs) or could be picked up on the Ward Environmental Audits.

Further to Minute 5(b) of the previous meeting, it was suggested that the issue of no rails on the steps at the northern interchange of the station should be referred to officers in the Transport Section.

Further to Minute 5(b) of the previous meeting, Helen Bryant reported that the issue of noise in Broad Street, that made navigating the street particularly difficult for blind people, had been referred to officers in the Licensing Section.

AGREED: That the position be noted.

3. SIMON PROJECT UPDATE

Helen Bryant reported that there were currently technical problems with the SIMON Project. The project was aimed at promoting the independent living and societal participation of mobility impaired people in the context of public parking areas and multiple transport modes, through the adoption of specific navigation information and Helen was due to attend a meeting about the project in October 2016.

The Group also discussed the decision taken by the Traffic Management Sub-Committee on 14 September 2016 (Minute 31 refers) to increase the number of Pay and Display parking bays in the town centre and agreed that an officer from the Transport Section should be invited to the next meeting to talk through the issues.

AGREED:

- (1) That the position be noted;
- (2) That an officer from the Transport Section be invited to the next meeting to talk through the issues around the expansion of the number of pay and display parking bays in the town centre.
