- (3) agree transitional arrangements for the Council pending the new form of executive arrangements coming into operation
- (4) appoint the Leader of the Council
- (5) appoint the Deputy Leader and Lead Councillors who would form the Cabinet of the Council;
- (6) agree the powers and duties of Committees and consultative Working Parties;
- (7) agree delegations to officers where appropriate in respect non-executive functions under Schedule 1 and "local choice" functions under Schedule 2 of the Local Authorities (Functions and responsibilities) (England) Regulations 2000 where the responsibility for exercising the function was retained by the Council
- (8) confirm those Councillors who met the definition of Members having significant responsibilities in relation to the discharge of the Council's functions in terms of entitlement to Special Responsibility Allowance at Tier Three (£1,030 a year) for the remainder of the financial year 2001/02.

The report stated that the constitution for the authority had been circulated under separate cover. This included, at Part 4, the updated procedural Standing Orders for the Council and its Committees (Council Procedure Rules)

The report had attached:

- (a) the recommended powers and duties (Appendix A);
- (b) the allocation of responsibility for functions which might not be the responsibility of the Cabinet, under Schedule 1 of Regulation 3(1) of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000 (Appendix B); and
- (c) the allocation of responsibility for "local choice" functions under Schedule 2 of Regulation 3(1) of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000 (Appendix C).

The recommendations set out in the report were:

"A. Constitution and Form of Executive Arrangements

 - a) subject to (b) below, the constitution for the authority, as circulated to all Councillors, be agreed and adopted

- 2.2 That the Head of Legal Services be authorised to publish a notice to the effect of (b) above in at least one local newspaper in accordance with Section 29 of the Local Government Act 2000, and to make copies of the constitution (in which the executive arrangements are set out in Article 7 and Part 4) available for public inspection
- 2.3 That the Leader prepare and publish the first forward plan for the Cabinet for 1 September 2001, and the Head of Central Administration arrange for public notice of this to be published during August 2001, in accordance with the provisions of Regulation 12 of the Local Authorities (Executive Arrangements) (Access to Information) Regulations 2000.
- 2.4 That the Head of Legal Services be authorised to incorporate into the constitution any specific statutory requirements that may be made by Parliament between this meeting of the Council and 1 September 2001.

B. General Reservation of Powers to the Council

 - Crime and Disorder Reduction Strategy;

- Early Years Development Plan;
- Education Development Plan;
- Local Transport Plan;
- Plans and strategies which together comprise the Development Plan;
- Youth Justice Plan.
- (ii) those other plans and strategies which the Council and the Cabinet consider should be adopted by the Council as a matter of local choice but in accordance with Government guidance.
 - Council's Corporate Plan (if any);
 - Food Law Enforcement Service Plan;
 - The plan and strategy which comprise the Housing Investment Programme;
 - Adult Learning Plan;
 - Local Agenda 21 Strategy;
 - Quality Protects Management Action Plan.
- (iii) Other Local Plans etc
 - Capital Strategy
 - City 2020
 - Cultural Strategy
 - Education Asset Management Plan
 - Environment Strategy
 - Equalities Strategy
 - Lifelong Learning Development Plan
 - Treasury Management Strategy

The budget framework is as set out in Part 4 of the constitution

- (c) subject to the urgency procedure contained in the Access to Information Procedure Rules in Part 4 of the Constitution, making decisions about any matter in the discharge of an executive function which is covered by the policy framework or the budget where the decision maker is minded to make it in a manner which would be contrary to the policy framework or contrary to/or not wholly in accordance with the budget;
- (d) appointing the Leader and Members of the Cabinet;
- (e) agreeing and/or amending the terms of reference for committees, deciding on their composition and making appointments to them;
- (f) adopting a Members' allowances scheme under Article 2.5 of the constitution:
- (g) changing the name of the area, conferring the title of freedom or freeman of the Borough;

- (h) confirming the appointment of the Head of Paid Service;
- (i) making, amending, revoking, re-enacting or adopting bylaws and promoting or opposing the making of local legislation or personal Bills;
- (j) all local choice functions set out in Part 3 of this Constitution which the Council decides should be undertaken by itself rather than the Cabinet, unless the function has been delegated by the Council to a Committee or an officer;

These local choice matters are as follows:

- Any function under a local Act other than a function specified or referred to in Regulation 2 or Schedule 1 of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000
- The making of arrangements to enable questions to be put on the discharge of the functions of the Police Authority under Section 20 of the Police Act 1996
- Any function related to contaminated land
- The passing of a resolution that Schedule 2 to the Noise and Statutory Nuisance Act 1993 should apply in the authority's area
- (k) setting the strategic vision and corporate objectives of the Council
- (l) agreeing the Council's capital strategy and asset management plan
- (m) determining and resolving the Council's position on planning, strategic minerals and waste, and other matters under consideration by the Berkshire Joint Strategic Planning Committee;
- (n) those matters assigned to the Council in Part 3 of this Constitution
- (o) all other matters which, by law, must be reserved to Council.

General Delegation of Powers

In respect of transitional arrangements, the Policy and Implementation Committee shall have all the powers and duties of each Committee and of the Council (except where statute requires otherwise), to enable it to deal with matters of urgency, subject to the report to the Committee setting out why the matter in question is so urgent that it cannot wait until the next Council meeting.

C. Powers and Duties of Committees
