- agree the powers and duties of committees, sub-committees, partnerships and consultative Working Parties (Appendices A, B and C);
- (4) agree changes to the Constitution
 - Part 2: Articles 4 and 8 To remove the adoption of the Joint Strategic Needs Assessment from the list of matters reserved to full Council in Article 4 of the Constitution.
 - Part 4: Rules of Procedure
 - (a) Contracts Procedure Rules To adopt formally the Contracts Procedure Rules, which had been considered at the Council meeting on 26 January 2016 (Appendix D).
 - (b) Planning Code of Conduct To amend the Planning Code of Conduct, which had been updated in October 2015, to clarify the position in relation to member site visits in para. 10.2 as set out in 2.15(c) below.
 - Part 5: Protocol for Webcasting and Recording of Council and Committee Meetings To agree formally the procedure for the

recording of Council meetings and transmitting them on the Council's website (Appendix E).

- (5) agree the general dispensation granted to all Members as set out in para. 2.18 below, and agree the changes to the Council's scheme of officer delegation as set out in para. 2.19 below relating to:
 - Head of Customer Services non-domestic rating
 - Head of Legal & Democratic Services convening education appeals and review panels
 - Director of Environment & Neighbourhood Services -land and property
 - General Delegation to officers award of contracts
- (6) amend the Council's scheme of Councillors' Allowances, and confirm those Councillors who met the definition of Members having significant responsibilities in relation to the discharge of the Council's functions in terms of entitlement to Special Responsibility Allowance at Tier 3 for the remainder of the financial year 2016/17;
- (7) re-establish the Remuneration Panel for the Municipal Year 2016/17;
- (8) appoint the interim Managing Director.

The Constitution for the authority would be amended in the light of these changes and published on the Council's website.

 - (ii) confirming the dismissal of the Head of Paid Service, Chief Finance Officer and Monitoring Officer;
- (h) making, amending, revoking, re-enacting or adopting bylaws and promoting or opposing the making of local legislation or personal Bills;
- (i) requesting a change to single-member electoral areas, and passing a resolution to change the Council's scheme of elections;
- (j) reorganisation of community governance making an order giving effect to recommendations made in a community governance review under Section 86 of the Local Government and Public Involvement in Health Act 2007;
- (k) promoting and maintaining high standards of conduct by Councillors and Co-opted Members, including adopting a local Member code of conduct and establishing a local Standards Committee;
- (I) passing a resolution to make a change in governance arrangements for the authority under Section 9KC(1) of the Local Government Act 2000 as amended by Schedule 2 of the Localism Act 2011;
- (m) those functions set out in Part 3 Schedules 2 and 3 of the Council's Constitution which are shown as being for the Council to exercise, and which the Council has not delegated to a Committee or an officer;
- (n) setting the strategic vision and corporate objectives of the Council;
- (o) making referrals to the Secretary of State, the regulator or the NHS Commissioning Board arising from the exercise of the health scrutiny function of the authority, under Section 22A of the National Health Service Act 2006 (as added under Section 190(3) of the Health & Social Care Act 2012);

- (p) entering into joint arrangements with other local authorities under sections 101 and 102 of the Local Government Act 1972;
- (q) all other matters which, by law, must be reserved to Council.

N. <u>The Council's Constitution</u>

a) <u>Council and Health and Wellbeing Board</u>

In Part 2, Article 4 of the Constitution, The Council, the adoption of the Joint Strategic Needs Assessment (JSNA), on the recommendation of the Health and Wellbeing Board, has been listed as a reserved matter for full Council to determine. The JSNA is now entirely web-based and individual JSNA modules will be reviewed on an ongoing basis following revised data, from both national and local sets. This will ensure that the JSNA is updated as new data is released and reviewed appropriately before being uploaded onto the JSNA website. As a result, it is considered appropriate that the Health and Wellbeing Board should be given delegated authority to oversee the JSNA and approve its adoption, where necessary.

This change requires the removal of the adoption of the JSNA from the list of matters reserved to full Council in Article 4 of the Constitution; and this function being reflected in the terms of reference of the Health and Wellbeing Board at Article 8 of the Constitution.

b) <u>Contracts Procedure Rules</u>

At its meeting held on 26 January 2016 (Minute 38 refers), the Council agreed to update its Contracts Procedure Rules (CPRs), which are included in Part 4 of the Constitution. The CPRs have been updated to reflect the Public Contracts Regulations 2015 and the Local Government Transparency Code 2014. The revised CPRs as set out in the report to Council on 26 January 2016 were agreed for formal adoption and inclusion in the Council's Constitution from the date of this meeting on 25 May 2016. The revised CPRs are attached to the report at Appendix D.

c) <u>Planning Code of Conduct</u>

The Planning Code of Conduct, which was updated by Council on 20 October 2015 (Minute 28 refers), requires clarification in relation to member site visits. In practice there are unaccompanied site visits where Members, perhaps on the recommendation of officers, attend to view the application site from the public highway or other public land. There are other visits that are accompanied by an officer where the Members and the officer attend the application site itself and assess the proposed development. The planning merits are not discussed with the Applicant or any objectors that may be present.

These visits are not formal sub-committee meetings and thus formal records are not taken. However if something relevant arose as a result of the site visit officers would include this in the Update Report and / or their verbal

presentation to Committee. Accordingly, the following amendment to paragraph 10.2 of the Code is required:

That the wording of paragraph 10.2 of the Planning Code of Conduct be changed from: "They consist simply of an inspection by a Viewing Sub-Committee, with officer assistance,...." to: "They consist simply of an inspection by members of the Planning Applications Committee, with officer assistance".

d) <u>Protocol for Webcasting and Recording of Council and Committee</u> <u>Meetings</u>

The Council has been recording meetings and broadcasting them on its website since the Council meeting on 7 July 2015. The Council is asked to approve the Protocol for Webcasting and Recording of Council and Committee Meetings (Appendix E), which describes the procedure to be followed when a meeting is being recorded and broadcast. The revised document also includes provisions previously covered in the protocol for Recording Proceedings of Council and Committee Meetings. The Protocol will be included in Part 5 of the Council's Constitution.

0. <u>Scheme of Members' Allowances for the Financial Year 2016/17</u>
