## APPLICATION FOR THE REVIEW OF A PREMISES LICENCE

1. Premises: C and K Food and Wine 467 Northumberland Avenue Reading RG2 8LZ

## 2. Applicants Requesting Review:

Peter Narancic on behalf of Reading Borough Council Licensing

## 3. Grounds for Review

Reading Borough Council's Licensing team submitted an application for the review of a premises licence for the premises stated above. The application states that the premises has a litany of offences and a history of non compliance dating from 2010 all the way through to 2014 that are contrary to the Licensing Act 2003 and the promotion of the Licensing Objectives. The application lists the issues associated with the premises and documents the steps taken by Reading Borough Council and Thames Valley Police culminating in the review application being made. The premises has previously been subject to a review application which was heard by the Licensing Committee on 2<sup>nd</sup> September 2011. At this hearing the premises licence was suspended for 1 week and new conditions placed upon the licence. The latest review application served by the Licensing Team seeks revocation of the premises licence and lists the reasons why this is being sought.

A copy of the review application received is attached as Appendix I
5. Date of closure of period for representations: 15 January 2015

## 6. Representations received:

Representations have been received in support of the review application from Thames Valley Police (*at Appendix II*), Reading Borough Council Trading Standards (*at Appendix III*) and Reading Borough Council Environmental Health (*at Appendix IV*).

À plan showing the location of the premises (in black) and surrounding streets is attached as *Appendix V*.

## 7. Background

The premises is located in Northumberland Avenue within a parade of shops surrounded by residential dwellings. It trades as a grocery store and off licence. The venue holds a premises licence which permits the sale of alcohol off the premises between 0800hrs and 2300hrs on Monday to Saturday and 1000hrs to 2230hrs on a Sunday. A copy of this licence is attached as **Appendix VI**.

The Premises Licence Holder is: Mr Paulambhai Bhupendra Patel & Mrs Shitalben Paulambhai Patel

The Designated Premises Supervisor is: Amit Kumar

The premises currently has the benefit of a premises licence for the activities and hours detailed below:

8. Licensing Objectives and Reading Borough Council's Licensing Policy Statement

In determining this application the Licensing Authority has a duty to carry out its functions with a view to promoting the four licensing objectives, which are as follows:-

- the prevention of crime and disorder;
- public safety
- the prevention of public nuisance
- the protection of children from harm

In determining this application the Licensing Authority must also have regard to the representations received, the Licensing Authority's statement of licensing policy and any relevant section of the statutory guidance to licensing authorities.

9. Power of Licensing Authority on the determination of a Review

In determining the application the sub-committee can take such of the steps as it considers reasonably necessary for the promotion of the licensing objectives, which are:

- 1. take no further action
- 2. to issue formal warnings to the premises supervisor and/or premises licence holder
- 3. modify the conditions of the licence (including, but not limited to hours of operation of licensable activities)
- 4. exclude a licensable activity from the scope of the licence
- 5. remove the designated premises licence supervisor
- 6. suspend the licence for a period not exceeding three months
- 7. revoke the licence.

Where the sub-committee takes a step mentioned in 3 or 4 it may provide that the modification or exclusion is to have effect for a period not exceeding three months or permanently.

## Home Office Guidance

Section 182 of the Licensing Act 2003, October 2014.

Reviews arising in connection with crime:

- 11.24 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises; money laundering by criminal gangs, the sale of contraband or stolen goods, or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.
- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them
- 11.26 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives in the interests of the wider community and not those of the individual licence holder.

## Please state the ground(s) for review (please read guidance note 1)

The Licensing Authority has applied for the review of this premises licence, which operates as an off-licence, as over a number of years they have had a catalogue of issues which have given serious cause of concern for Reading Borough Council's Licensing Section, Trading Standards and Thames Valley Police. The premises licence holders, Mr Paulambhai Bhupendra PATEL and Mrs Shitalben Paulambhai PATEL have consistantly failed to comply with licensing law and the terms and conditions of their premises licence, despite being given help and support from the responsible authorities, which has resulted in Mr and Mrs PATEL undermining the Licensing Objectives, which underpin the Licensing Act 2003.

Mr PATEL and Mrs PATEL are joint premises licence holders for these premises and have operated this business, formally known as Kush Food and Wine since 2007. They also own other Off licence premises in Reading.

Mr PATEL also holds a personal licence holder (LP7000491), which was issued by Reading Borough Council in 2005.

The premises were visited on 21 January 2010 by a Reading Borough Council Senior Licensing and Enforcement officer. Following the Inspection, Mr and Mrs PATEL were advised by letter in regard to staff training, keeping a refusal register, operating challenge 25 and other advice. The Officer did not receive a reply. Please refer to Appendix I.

The premises were visited on 16 September 2010 by a Senior Licensing and Enforcement officer. Following the inspection, Mr and Mrs PATEL were advised by letter regarding several breaches of their terms and conditions and licensing law in

regard to the premises not having a copy of their premises plan or a Section 57 notice, which names the staff member responsible for producing part A of the premises licence, when the designated premises supervisor is not there, displayed in the premise. Advice was given in regards to premises conditions, staff training, new mandatory conditions and other matters. The Officer did not receive a reply. Please refer to Appendix II.

Following this inspection, the Licensing Section informed Trading Standards about their concerns regarding the operation of this business. On the 19 July 2011 the Chief Inspector of Weights and Measures applied to review the pemises licence as staff at the premises failed three test purchase exercises. The Licensing Committee resolved that the premises licence be suspended for one week and additional conditions were attached to the premises licence. Please refer to Appendix III.

In addition, preceding the review, Mr PATEL and an employee were prosecuted in Reading Magistrates Court for selling tobacco to underage persons. They were both found guilty in their absence. Mr PATEL was fined £1500 plus costs.

The premises were visited on 20 July 2012 by a Senior Licensing and Enforcement officer. The designated premise supervisor, Mrs Roshiben PATEL was not present. Following the inspection, Mr and Mrs PATEL were advised by letter in regard to not having part A of the premises licence, not having a Section 57, not having an age verification policy displayed, reminded that staff must be qualified to sell alcohol, the designated premise supervisor not being at the premises and other matters. They were also warned about what might happen if there were any future breaches of the terms and conditions of their premises licence. A copy of the conditions were attached. The Officer did not get a reply. Please refer to Appendix IV.

The premises were visited on 4 October 2012 by a Senior Licensing and Enforcement officer. Mr PATEL was present but not his designated premises supervisor, Mrs Roshiben PATEL. Following the inspection, Mr and Mrs PATEL were advised by letter in regard to not having a incident register, staff training, not having a current copy of their part A or part B premises licence, not having an age verification policy, not having a Section 57, the designated premises supervisor not being at the premises and other matters. They were again warned about what might happen if there were any future breaches of the terms and conditions of their premises licence. A copy of the premises licence and conditions were attached. The Officer did not receive a reply. Please refer to Appendix V.

The premises were visited on 13 June 2014 by a Senior Licensing and Enforcement officer. The designated premises supervisor, Mrs Roshiban PATEL was not present. Following the inspection, Mr and Mrs Patel were advised by letter in regard the designated premises supervisor not being present during this and previous inspections, part B summary of the premises licence being altered by hand to change the premises name to C&K Food and Wine, not having a shop plan, not having a section 57 notice, not having an written age verification policy, staff training and other matters. They were given a final warning and reminded what might happen if there were any future breaches of the terms and conditions of their premises licence. A copy of the premises licence and conditions were attached. The Officer did not receive a reply, however Mr and Mrs Patel applied to licensing to change the name of the premises to C&K Food and Wine. Please refer to Appendix VI.

A letter dated 3 July 2014 requesting information was sent to the named designated premises supervisor, Mrs Roshiban PATEL. A copy of the premises licence and condtions were attached. Please refer to Appendix VII. Mrs PATEL's, reply, dated 7 July 2014, is shown at Appendix VII.

A further letter dated 7 July 2014 was sent to Mr and Mrs PATEL in regard to information supplied by Mrs Roshiban PATEL confirming, she ceased being the named designated premises supervisor for the premises in 2012. Under the Licensing Act, this meant that alcohol sales had to cease immediately until Mr and Mrs PATEL applied to vary the premises licence to add a new designated premises supervisor. The Officer did not receive an explanation to why they failed to notify Licensing and continued to operate their business illegally without a designated premises supervisor from 1<sup>st</sup> July 2012 to July 2014. Please refer to Appendix IX.

For clarification, a designated premises supervisor (DPS) is the person identified on the premises licence as the person who supervises the premises and authorises each and every sale of alcohol staff make. Any premises where alcohol is supplied under a premises licence must have a designated premises supervisor. They will be named in the premises licence, a summary of which must be displayed on the premises. They will be the points of contact for the premises at all times for licensing authorities, or the Police or Fire Services if problems occur at the premises. Any application for a premises licence must also include a form of consent given by the individual whom the applicant wishes to have specified in the premises licence as the designated premises supervisor. They are not required to be at the premises at all times, however, following the previous review hearing in 2011, the designated premises for these premises was required to be actively employed at the premises.

The Mandatory condition which applies where a premises authorises the supply of alcohol states;

1. That no supply of alcohol may be made under the premises licence:-

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2 Every supply of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

On 11 July 2014, Mr and Mrs PATEL applied to vary their premises licence to add a new designated premises supervisor, Mr Honey SINGLA.

However, on 23 July 2014, Thames Valley Police objected to the proposed designated premises supervisor, Mr SINGLA because he had a relevant criminal conviction. Please refer to Appendix X.

A letter dated 4 August 2014, was sent to Mr and Mrs PATEL advising them both that Mr SINGLA had withdrawn his consent to be the designated premises supervisor and advising them that the sale of alcohol must cease. Please refer to Appendi XI.

On 13 August 2014, a Senior Licensing and Enforcement officer visited the premises. Mr and Mrs PATEL were not present. He confirmed all alcohol had been covered up and staff were aware that alcohol could not be sold or displayed. The premises were being looked after by person named HARRY. He left another copy of the letter dated 4 August 2014, for Mr and Mrs Patel and their staff. He was informed Mr PATEL was abroad.

On 22 August 2014, Mr and Mrs PATEL applied to vary their premises licence to add a new designated premises supervisor, Mr Sayed ESRAR. Premises licence number

LP2001591 was issued on 3 September 2014. The licence was posted out to Mr and Mrs PATEL. Please refer to Appenix XII.

On 23 October 2014, the Licensing section received information from the Trading Standards section that when they visited the premises with a test purchaser, although aged over 18, looked younger than 25. The member of staff behind the counter failed to ask for proof of age and sold alcohol to him. This was a breach of both the premises conditions, and the Government's mandatory conditions in respect of having an age verification policy. The premises are required to operate challenge 25. They were concerned that the staff working there were poorly trained in regards to the Licensing Act 2003.

The premises were visited on 5 November 2014, by a Senior Licensing and Enforcement officer accompanied by a Thames Valley Police officer. When staff were questioned, they did not know who the designated premises supervisor was. They telephoned Mr Honey SINGLA, who was looking after the premises while Mr and Mrs PATEL were abroad. When he arrived, he too did not know who the designated premises supervisor was. He told the officer he was planning to take the business over, but was waiting for Mr PATEL to return. When questioned further, they did not have the most up to date part A or part B summary of the premises licence (Appendix XII) nor a Section 57. The two staff members admitted they were not qualified to BlI level one despite being employed there for more than 28 days, (they were the same staff seen by the officer in June 2014), which was a specific condition on the premises licence. It meant that unqualified staff could not sell alcohol. Mr SINGLA, who held a personal licence agreed that all alcohol would be covered up and not sold, when he was not in the premises.

Later the same day, the officer checked Reading Borough Councils premises records. He confirmed the named designated premises supervisor on the premises licence was Mr Sayed ESRAR. The Licensing Officer telephoned Mr ESRAR, who told the officer he did not know he was the designated premises supervisor for C&K Food and Wine, 467 Northumberland Avenue, Reading. As this was important information the Officer asked him to confirm what he had told him in writing. Mr ESRAR confirmed in this writing on 6 November 2014. Please refer to Appendix XIII.

On 6 November 2014, the Licensing officer and two Thames Valley Police officers re-visited the premises to deliver letters addressed to Mr and Mrs PATEL, Mr SINGLA and the staff requiring the sale of alcohol to cease immediately. They found the alcohol covered up with alcohol not for sale notices. He spoke to Mr SINGLA on the telephone, and explained the contents of the letter, with a strong warning to the possible consequences if alcohol was sold or displayed. Please refer to Appendix XIV.

Later the same day Mr ESRAR telephoned and emailed the Licensing officer to ask to revert back to being the designated premise supervisor claiming he made a mistake. The Licensing officer told him this wasn't possible as he was not the premises licence holder. He suggested he speak to Mr PATEL or his solicitor for advice. Please refer to Appendix XV.

On 21 November 2014, Mr and Mrs PATEL applied to vary the premises licence to add a designated premises supervisor, Mr Amit Kumar. As there were no objections from Thames Valley Police, a new premises licence was issued. It was hand delivered to Mr and Mrs PATEL's registered address. Please refer to Appendix XVI

Please provide as much information as possible to support the application (please read guidance note 2)

These premises have been found selling alcohol without having a designated premises supervisor actively employed at the premises, the longest period being two years. Records show Mr and Mrs PATEL had ample oportunity to notify the Council about this, but failed to do so. Despite having their premises licence suspended, following the previous review and Mr PATEL fined a substantial amount by Reading Magistrates Court for selling tobacco to a young person, they have clearly chosen not to comply with Licensing law and the terms and conditions conditions of their premises licence. Therefore have failed to support the Licensing Objectives and are willing to continue to take further risks with their business and to damage the local community.

As such, the Licensing Section recommends that the premises licence for C&K Food and Wine should be revoked.

On Thursday 21 January 2010 I visited your premises to ensure you are complying with the above premises licence. I spoke with your employee Mr Darshn Patel.

During my inspection, I found several items that require your attention as outlined below.

The Minutes of the meetings of Licensing Applications Sub-Committee 2 held on 1 and 8 July and 5 August 2011 were confirmed as correct records and signed by the Chair.

## 8. APPLICATION FOR THE REVIEW OF A PREMISES LICENCE - KUSH FOOD & WINE

The Head of Environment and Consumer Services submitted a report on an application by the Chief Inspector of Weights and Measures, Reading Borough Council, for the review of the Premises Licence in respect of Kush Food & Wine, 467 Northumberland Avenue, Reading.

The report stated that a review of the Premises Licence had been requested as a result of three failed test purchase exercises when alcohol and tobacco had been sold to an underage person. The report stated that the Premises Licence holder had undermined the licensing objectives to protect children from harm and prevent crime and disorder.

A copy of the review application was attached to the report at Appendix I. This gave further details of the grounds for the application, including details of the three failed test purchase exercises that had taken place on 22 May 2010, 27 July 2010 and 2 July 2011. The report also gave details of a test purchase which the premises had passed on 30 July 2011. The application was seeking the suspension of the Licence and for additional conditions to be attached to the Licence.

No other representations had been received in respect of the application. A plan showing the location of the premises and the surrounding area was attached to the report at Appendix II.

The report stated that the Premises Licence holder was Mr P Patel and Mrs S Patel. The existing Premises Licence, a copy of which was attached to the report at Appendix III, permitted the sale of alcohol by retail, off the premises.

The report stated that in considering the application, the Licensing Authority had a duty to carry out its functions with a view to promoting the four licensing objectives, as follows:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

The report stated further that, in determining the application, the Sub-Committee could take the following steps:

- Take no further action;
- Issue formal warnings to the premises supervisor and/or premises licence holder;
- Modify the conditions of the licence;
- Exclude a licensable activity from the scope of the licence;

- Remove the Designated Premises Supervisor;
- Suspend the licence for a period not exceeding three months;
- Revoke the licence.

(Where the Sub-Committee took a step mentioned in the third and fourth bullet points above it may provide that the modification or exclusion was to have effect for a period not exceeding three months or permanently.)

Mr Ian Savill, Senior Trading Standards Officer, Reading Borough Council, was present at the meeting and addressed the Sub-Committee on the application and responded to questions. Mrs S Patel was present at the meeting. She was accompanied and represented by Mr William Donne, Silver Fox Licensing Consultants, who addressed the Sub-Committee and responded to questions. Mr William Donne reported at the meeting that Mrs Patel was now the Designated Premises Supervisor for the Premise.

## **Resolved** -

- (1) That, having reviewed the Premises Licence in respect of Kush Food & Wine, 467 Northumberland Avenue, Reading, and having had regard to the licensing objectives of the prevention of crime and disorder and the protection of children from harm, the oral and written representations made by all parties, the Secretary of State's guidance in particular paragraphs 11.17 and 11.26, and the Council's Statement of Licensing Policy, the Sub-Committee concluded that it was necessary and proportionate to suspend the Premises Licence for one week and conditions be attached to the Licence as set out in (2) below;
- (2) That the conditions proposed by Trading Standards be amended and attached to the Licence as follows:
  - (a) all incidents which undermine any of the four licensing objectives shall be recorded in a register kept at the premises for this purpose. During my inspection, I found the following items that require your attention as outlined below. If you recall many of these conditions were placed on your licence at a hearing as a result of illegal sales to children. You are already aware that for each breach of your licence conditions is an offence, if found guilty, it could result in six months imprisonment and or a £20,000 fine for each breach.

- 1. You have a specific condition where your Designated Premises Supervisor shall be actively employed on the premises and shall not be a Designated Premises Supervisor for premises elsewhere. I did not see Mrs Roshiben Patel at the premises during my inspection, nor have I ever seen her or spoken to her on any previous occasion. If you cannot comply with this condition, please consider varying your licence to add a new Designated Premises Supervisor who can be as a matter of urgency.
- 2. I saw a copy of your Part B of your premises licence displayed in your premises, which had been illegally amended by hand to indicate a change of name to C&K.
- 3. Please ensure you have a copy of your original shop plan available for inspection.
- 4. Please ensure you have a Section 57 notice in place (in regard to part A of the premises licence) at your premises.
- 5. Please ensure you have a written age verification policy in place.

(d) That the premises shall at all times operate a Challenge 25 policy to prevent any customers who attempt to purchase alcohol and who appear to the staff member to be under 25 years from making such a purchase without first have provided identification. Only a valid British driver's licence showing a photograph of the person, a valid passport or proof of age card showing the 'Pass' hologram are to be accepted as identification;

(e) Notices advertising the Challenge 25 policy shall be displayed in prominent positions on the premises;

(f) The Premises Licence Holder shall display in a prominent position a copy of their policy on checking proof of age;

(g) All staff shall be refresher trained on the law relating to underage sales every three to four months and how to question and refuse sales if necessary, utilising the Challenge 25 policy. Records of training and reminders given shall be retained and made available to authorised officers of Reading Borough Council or Police Officers on request;

### **Review of the Premises Licence for C&K Food and Wine**

Thames Valley Police wish to raise its support for the review of the premises licence. It considers that the licence holders have had complete indifference for the Four Licensing Objectives and the Licensing Act 2003 in the way in which they have conducted their business. This, despite being assisted by Reading Borough's Council's Licensing Officer. Mr Patel is a Personal Licence Holder and as such should have been aware of his responsibilities in relation to being granted a Premises Licence by the Licensing Authority.

The licence holders have been given advice in relation to the training of the staff and other issues surrounding the Four Licensing Objectives. The premises staff failed three test purchase operations; something that would not have happened if the licence holders had trained their staff to a level that would have negated this and as a result would not have had the premises licence suspended. In all of this the Licence holders have not approached the Licensing Authority for assistance and guidance in these matters.

In all there have been nine visits to the premises by responsible authorities and there has been a consistent lack of response demonstrated by the licence holders in respect of the advice given to them by the Council. Mr Patel has shown that he does not regard the law as something that he must heed as he was fined by Reading Magistrates Court along with a member of his staff for selling tobacco and alcohol to children. He did not even bother to attend court.

Incredulously, the licence holders did not know that they had no DPS at the premises for a period of two years and submitted an individual to fill this post. TVP, having conducted its checks on this person it was found that he was unsuitable. TVP met with the proposed DPS and at the end of the meeting he advised TVP that he would be withdrawing his consent. It is incredible that Mr Patel, a personal licence holder and a premises licence holder would not have the capability of ensuring that the premises had a responsible individual to run the business.

From January 2010 to the date of this application there has been a catalogue of failings by the licence holders either by ignorance or disregard for their responsibilities in running a business part of which is the sale of alcohol. The Four Licensing Objectives were penned to ensure the safety and well being of members of the public and not to be a burden on the Local Authority. Other businessmen and women have been granted Premises Licenses and by and large conduct their trade in accordance with the conditions attached to the premises licence and more importantly the Four Licensing Objectives.

TVP feel that the history of the premises and the lack of indifference to the Four Licence Objectives, the Licensing Act 2003 and the conditions attached to the premises licence that the holders of the premises licence are not fit and proper persons to hold the licence.

This relates to an application for the review of a premises license submitted by Reading Borough Council's Licensing Service on the 18<sup>th</sup> December 2014. The Trading Standards Service, as a responsible authority under the Licensing Act 2003, support the action being taken and also take this as an opportunity of submitting additional information for inclusion at the review.

In order to establish whether a premises is upholding the Licensing Act 2003 duty of protecting children from harm and the prevention of crime and disorder, test purchase operations take place where an under age volunteer is asked to buy age restricted goods from licensed premises.

The premises chosen for the exercises are usually intelligence lead, that is, where complaints have been received from the general public or local Neighbourhood Police Officers have become aware of problems. Back in 2010, information was received from Thames Valley Police indicating that, what was trading then as Kush Food & Wine, 467 Northumberland Avenue, Reading may be a source of alcohol for under age young people. On the  $22^{nd}$  May 2010, the shop was test purchased and sold alcohol to an underage volunteer. A follow up test purchase took place on the  $3^{rd}$  June 2010, also for alcohol, the shop passed.

However, on the 28<sup>th</sup> July 2010, a test purchase took place at 467 Northumberland Avenue, Reading for tobacco and the shop sold a packet of ten Benson and Hedges cigarettes from a member of staff at the shop. Mr Paulambhai Patel was prosecuted but he failed to turn up at court. He was fined £1500 plus £400 costs and a £15 victim surcharge.

On the 4<sup>th</sup> July 2011 a further test purchase took place and alcohol was sold to an underage volunteer. A licence review followed and a week's suspension was

imposed along with conditions including to training of staff within 28 days of employment and a Challenge 25 age verification policy.

In October 2014, as part of a Challenge 25 test purchasing programme to benchmark all off licenced retailers for a Community Alcohol Partnership, the premises and an 18 year old was able to purchase alcohol without being asked for proof of age.

The Community Alcohol Partnership Officer then visited the shop to discuss the issue and it became obvious that there were no controls around training, Licensing Act 2003 obligations and other rudimentary due diligence procedures. The member of staff consulted by the CAP Officer had worked there for four months but had not received training in accordance with the licence conditions.

On the basis of the history and continuing issues that the premises presents, there is a total lack of control by the Premises Licence Holder. He appears to take complying with the law as an option rather than an obligation. The Trading Standards Service fully supports the Licensing team's licence review of 467, Northumberland Avenue, Reading and also recommends revocation.

Looking at the records for the last food hygiene inspection at this premises on 9/9/2014 it shows signs of <u>poor</u> <u>management</u> ie no written food safety procedures, especially no temperature monitoring for high risk food, poor training of staff with them not knowing correct temperatures for the fridge, food found for sale past its 'use by' date despite Mr P Patel receiving repeated advice regarding these matters.

In my dealings with Mr Paulam Patel, the owner, here and in other shops he owns I have found it was difficult to get compliance even after serving a hygiene improvement notice therefore the premises licence holders have failed to support the licensing objectives of public safety.



## Mandatory Conditions

## Supply of Alcohol

# To be applied where a premises licence authorises the supply of alcohol

- 1 No supply of alcohol may be made under the premises licence:
  - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2 Every supply of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

## Film Exhibitions

To be applied only where a premises licence or club premises certificate authorises the exhibitions of films

- 1 The admission of children to any exhibition of any film must be restricted in accordance with section 20 of Part 3 of the Licensing Act 2003.
- 2 In the case of films which have been classified by the British Board of Film Classification admission of children to films must be restricted in accordance with that classification.
- 3 In the case of films which have not been classified by the British Board of Film Classification, admission of children must be restricted in accordance with any recommendation made by the Licensing Authority.

## Door Supervisors

To be applied where a premises licence or club premises certificate includes a condition that any person must be at the premises to carry out a security activity. [Except premises with a premises licence authorising only plays or films or premises used exclusively by a club].

1 Each individual present at the licensed premises to carry out a security activity must be licensed by the Security Industry Authority.

# Responsible Drink Promotions (commencement date 01/10/2014)

1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Supply of Tap Water (commencement date 01/10/2014)

1. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy (commencement 01/10/2014)

1. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

2. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b) an ultraviolet feature.

Drink Measurements (commencement date 01/10/2014)

1. The responsible person must ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i) beer or cider: 1/2 pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

## Minimum Permitted Pricing (commencement 28th May 2014)

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1-

(a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b)"permitted price" is the price found by applying the formula-

 $\mathsf{P}=\mathsf{D}+(\mathsf{D}\mathsf{x}\mathsf{V})$ 

where-

(i) P is the permitted price,

(ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

# Conditions attached after a hearing by the Licensing Authority

(a) All incidents which undermine any of the four licensing objectives shall be recorded in a register kept at the premises for this purpose. The names of the person recording the information and those members of staff who deal with the incident shall also be recorded. Where known, any offenders' names shall also be recorded. The register shall be made available to an authorised officer of Reading Borough Council or a Police Officer on request;

(b) All persons authorised to sell alcohol shall be trained to at least the BIIAB Level 1 Award for Responsible Alcohol Retailing or any other similarly recognised nationally approved accreditation curriculum;

(c) All new members of staff shall be initially trained on age restricted sales before they are permitted to sell alcohol and registered within the 28 days of employment to attend, at a minimum, the BIIAB Level 1 Award for Responsible Alcohol Retailing or any other similarly recognised nationally approved accreditation curriculum;

(d) That the premises shall at all times operate a Challenge 25 policy to prevent any customers who attempt to purchase alcohol and who appear to the staff member to be under 25 years from making such a purchase without first have provided identification. Only a valid British driver's licence showing a photograph of the person, a valid passport or proof of age card showing the 'Pass' hologram are to be accepted as identification;

(e) Notices advertising the Challenge 25 policy shall be displayed in prominent positions on the premises;

(f) The Premises Licence Holder shall display in a prominent position a copy of their policy on checking proof of age;

(g) All staff shall be refresher trained on the law relating to underage sales every three to four months and how to question and refuse sales if necessary, utilising the Challenge 25 policy. Records of training and reminders given shall be retained and made available to authorised officers of Reading Borough Council or Police Officers on request;

(h) The Designated Premises Supervisor shall be actively employed on the premises and shall not be a Designated Premises Supervisor for premises elsewhere.
