3. Grounds for Review

Thames Valley Police submitted an application for the review of a premises licence for the premises stated above on 13th August 2015. The application details that the premises has been breached the conditions on its premises licence in relation to the provision of door supervisors and the use of the Club Scan device within the premises to carry out age verification. Breaches of conditions on an authorisation is contrary to Section 136 of the Licensing Act 2003.

Further, the application states that the premises has breached Section 141 of the Licensing Act which deals with the sale of alcohol to persons who are intoxicated; Section 145 which deals with unaccompanied children that are prohibited from certain premises and Section 146 which deals with the sale of alcohol to children. These incidents are detailed within the review paperwork. Appendix B and C of the review paperwork also state that a significant amount of incidents requiring police intervention have taken place at the premises which have undermined the prevention of crime and disorder licensing objective.

The review application served by the Thames Valley Police seeks a modification of the conditions contained on the premises licence and a two month suspension to allow them to be implemented.

8. Licensing Objectives and Reading Borough Council's Licensing Policy Statement

- 3. modify the conditions of the licence (including, but not limited to hours of operation of licensable activities)
- 4. exclude a licensable activity from the scope of the licence

- 5. remove the designated premises licence supervisor
- 6. suspend the licence for a period not exceeding three months
- 7. revoke the licence.

Where the sub-committee takes a step mentioned in 3 or 4 it may provide that the modification or exclusion is to have effect for a period not exceeding three months or permanently.

Representations from the Police

9.12 In their role as a responsible authority, the police are an essential source of advice and information on the impact and potential impact of licensable activities, particularly on the crime and disorder objective. The police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area.

The police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective, but may also be able to make relevant representations with regard to the other licensing objectives if they have evidence to support such representations. The licensing authority should accept all reasonable and proportionate representations made by the police unless the authority has evidence that to do so would not be appropriate for the promotion of the licensing objectives. Please provide as much information as possible to support the application (please read guidance note 2)

Thames Valley Police (TVP) as a responsible authority under the Licensing Act 2003 and under the objectives for the Prevention of Crime and Disorder and Public Safety, make an application for the review of Premises Licence No. LP001329, Zeus, Hosier Street, Reading, RG1 7JL.

On 10th October 2014 it became necessary to write to the venue formally requesting some outstanding CCTV footage which was required following incidents both inside and outside the venue. In addition, the door book was requested. The letter also raised concerns over a promotion that was due to take place at the premises during the forthcoming weekend. In addition the letter draws to the attention of the Designated Premises Supervisor (DPS) that the Clubscan identification device was not working and allegedly had not done so for some considerable time. **Please see Appendix A.**

On Wednesday 12th November 2014 TVP held a meeting with Mr Mursaloglu the Premises Licence Holder (PLH), Mr Adonis Daniel, the Solicitor for Mr Mursaloglu and Ms Sarah Saunders, the Security Representative for Mr Mursaloglu. Notes of the meeting were taken. **Please see Appendix B.**

During the meeting the recent history of the premises was discussed in terms of the number and type of incidents particularly, but not exclusively; intoxication, drugs and issues with the doorstaff which had been experienced at the premises by way of a review of the GEN40 Reports received concerning the premises. **Please see Appendix C.**

A revised set of proposed licence conditions was presented to Mr Mursaloglu and they were each individually reviewed. Following this it was recommended to Mr Mursaloglu to take the document away with him for discussion with his colleagues.

Please see Appendix D.

Concerns were also raised as to the competency of Ms Saka Muhrova, the DPS, who had been at the heart of some of the incidents that have occurred at the premises through poor management. Examples cited were; the overruling of decisions taken by the door staff, lack of openness with attending Police Officers etc. The response was that the situation with regard to Ms Muhrova would be examined.

Mr Mursaloglu was asked how long it would be before he could respond to the document. Mr Daniels advised that he would respond by Friday the 14th November 2014. One of the proposed conditions was the introduction of a Dispersal Policy. TVP advised that it already had such a policy and offered to email it to Mr Daniels which was agreed. **Please see Appendix E.**

On 17th November 2014 Mr Daniels emailed TVP with the response to the proposed new conditions. He advised that his client would be more than happy to accept the proposed conditions with exceptions to the ones relating to the door staff requirement; the last entry time, and the turning down of the recorded music to background level at 02.00 a.m. He also advised that steps were in place to remove the current DPS. **Please see Appendix F.**

On 16th December 2014 an informal meeting with Mr Mursaloglu, Mr Payne, the Barrister for Mr Mursaloglu and TVP was held at the premises with a view to finalising the detail surrounding the three outstanding proposed conditions. The stumbling points were discussed and it was agreed that there would be a response as soon as possible. To date no response has been received.

On 3rd January 2015 TVP received information that the management had reviewed the number of door supervisors required and had reduced this number from five to three thereby putting the safety of the public at risk, for example, by having two door staff on the front door and only one inside.

If there had been an incident inside the venue then potentially the door would have been left unmanned and thus exposed. Please see Appendix G1.

Historically, it can also be evidenced through GEN40 reports submitted by attending officers, that further incidents have taken place where there have been a reduced number of door supervisors thereby putting members of the public at risk. Please see Appendices G2, G3 and G4.

There is a condition on the Premises Licence, in Appendix 2, stating the requirement for the ratio of door supervisors to customers. The doorbook, throughout, has not been completed in a manner depicting the accurate number of customers in the venue at any one time whilst the premises have been open to the public.

It is accepted that there is no specific condition requiring the use of a doorbook. However, to accurately comply with the supervisor/customer ratio condition, TVP are of the opinion that the use of such a book, or equivalent, would be the only generally accepted method of evidencing compliance with this condition.

Given this, it can only be assumed that on the days shown in the analysis of the doorbook the maximum capacity of the venue, on those days, is calculated given the number of door supervisors employed on that particular day.

Therefore, assuming this, the appendix shows that the number of door supervisors booked on duty is correct, and the corresponding number of customers on each day is also correct. An analysis of these numbers has concluded that if these numbers are accurate TVP would call into question whether or not this condition is being complied with. **Please see Appendix H.**

On 6th January 2015 a telephone call was made by TVP to Mr Payne requesting an update on the discussions held on 16th December 2014. Mr Payne advised that he would pen a response by the end of the week as he had got caught up in something. There has been no response to date.

On 8th January 2015 TVP received an email from Mr Jon Payne on behalf of Mr Mursaloglu advising that he had finished drafting a dispersal policy and was awaiting some feedback from the premises. **Please see Appendix I.**

On 16th January 2015 an email was sent to Mr Payne requesting an update on the DPS removal situation. Mr Payne advised that Ms Muhrova would be removed as a member of staff as of 17th January 2015. **Please see Appendix J.**

However, on 26th January 2015, ten days later, a Temporary Event Notice (TEN) was received by TVP signed by Ms Sarka Muhrova. The TEN was for an event on 7th February 2015 to which TVP objected and a counter notice was served by Reading Borough Council (RBC). The TEN was later re-submitted by Mr Mursaloglu however, it was objected to by RBC and later withdrawn.

Please see Appendix K1, K2 and K3.

On Tuesday 3rd February 2015 a further, brief, meeting took place between TVP, Mr Mursaloglu, Ms Maria Wilson, an associate of Mr Mursaloglu, and Mr Joseph Borg, the new DPS. It transpired that Mr Borg had an incomplete knowledge of the situation prior to his appointment as the new DPS. It was explained to him that the premises had caused TVP some considerable difficulty in the way it was being managed.

It was explained to him that a new set of licence conditions had been proposed to the PLH and despite several approaches made to his Barrister, the three issues under discussion were still outstanding and if no movement had been made on them by 6th February 2015, TVP would have to give consideration to submitting the papers for a review of the Premises Licence. Mr Borg was advised that in order to clarify the situation he should contact Mr Mursaloglu's Barrister.

On 7th February 2015 a sixteen year old female and her boyfriend were found in a highly intoxicated state walking along Gun Street towards the Purple Turtle. It transpired that they had been drinking in Zeus Nightclub where they had both managed to consume a large quantity of alcohol and admitted to taking MDMA.

Following a search by a female officer it was established that the female had used another person's passport as a form of ID and she did not look anything like the female depicted in the document. According to her boyfriend the passport was hardly looked at by the doorstaff. The reporting officer advised in his GEN40 report that the drunk female admitted to being sixteen but looked only fourteen. Please see Appendix L.

On 17th April 2015 an email was sent by TVP to the manager of the venue requesting Mr Borg's email address. On receipt of this an email was sent to Mr Borg requesting an update as to the status of his ownership of the premise. On 19th April 2015 an email was received from Mr Borg advising that all the documentation would be complete by the end of April 2015 and copies would be sent to TVP. Nothing has been received. **Please see Appendix M1, M2 and M3.**

On 11th May 2015 a further email was sent to Mr Borg requesting an update as to the status of the premises. On 18th May 2015 a response was received from Mr Borg advising that he will keep TVP up to date, and that the venue would be closing for two weeks in June for a minor refurbishment.

Please see Appendix N.

On 30th May 2015 a GEN40 report was submitted advising of two separate incidents with underage consumption of alcohol within the premises. The first involved a female who was kicked out by the door supervisors and handed to the Police to deal with. (Please note the word SUE in the middle line of the last paragraph in the Appendix is meant to read USE). The second involved a young male who was later involved in an altercation in Friar Street. **Please see Appendix O.**

On 12th June 2015 TVP received a telephone call from Mr Borg advising that as of 15.59 p.m. he had resigned as the DPS for the premise and that a text had been sent to the PLH to that effect. A request was made that as soon as possible an email should be sent to TVP formally advising of his resignation. **Please see Appendix P.**

TVP attended the premise in order to make contact with the General Manager (GM). The GM permitted entry to the venue where the email from Mr Borg, received earlier, was handed to her. When the contents of the email had been read the GM was advised that the premises could open but only for the sale of soft drinks and all alcohol should be removed from public view otherwise an offence would be committed if members of the public were to be admitted to the club.

Telephone calls were made back and forth between the GM, Mr Borg and Mr Mursaloglu to a point where Mr Borg requested to speak to the Police where he advised that he had spoken with the PLH and that he would remain as the DPS and was withdrawing his resignation for the weekend.

He was advised that he must send an email to TVP reversing his resignation. He was also told that there had been some considerable wastage of Police time in what was a simple management issue that could have been resolved with the use of emails. Once the email from Mr Borg was received a telephone call was made to the GM where she was advised that all was in order for the weekend. **Please see Appendix Q.**

During the visit to the premises the GM was advised on two separate occasions that the premise licence was to be reviewed. Either out of dismissal or not hearing no contact was made to TVP to establish the circumstances surrounding the decision to review the Premise Licence.

In addition, to date, no contact has been made with TVP in relation to the proposed conditions put forward in the meeting on 12th November 2014. TVP feel that they are proportionate in that they support the four licensing objectives and formalise what is somewhat a sparse set of conditions, which are not too specific in their content.

On 4th July 2015 a GEN40 report was submitted in relation to a serious public order incident following what was later described as an R and B night at the venue. What began as a domestic violence incident resulted in the whole of the club being dispersed onto Hosier Street where there were between fifty and sixty persons present.

There were around thirty persons attempting to prevent officers controlling the situation and various persons were attempting to prevent officers affecting arrests. **Please see Appendix R.**

On 10th July 2015 a GEN 40 report was received regarding the officers interaction with the new door supervisors and the dispersal of the customers when the venue closes. **Please see Appendix S.**

On 11th July 2015 TVP attended the premises and met with the GM and her Head of Security. On entering the premises it was noticed that a complete alteration of the interior had taken place. It was pointed out to the GM that TVP had received no formal notification of an application for such an alteration. The GM advised that Mr Mursaloglu had said that as no walls were coming down it was alright.

TVP pointed out that the change certainly had implication for the Fire Service if they were to attend an emergency as the plan they had of the interior of the venue was not accurate and potentially could have consequences for their safety. The GM advised that that was never thought of. She was advised to contact the Council's Licensing Department for advice where she was advised that the works required an application for a variation to the premises licence.

This demonstrates the degree the lack of thinking and responsibility of the premises licence holder in conducting his business in a manner that is safe for not only members of the public but officers of the other blue light services.

On 17th July 2015 it was found necessary to issue a Notice under Section 19 of the Criminal Justice and Police Act 2001 for the continual failure by the Premises Licence Holder to have the Clubscan device in proper working order. **Please see Appendix T.**

In reference to breaches of the licence conditions, which are evidenced within the documentation, a full copy of the Premises licence is enclosed. **Please Appendix U.**

TVP have demonstrated an inordinate amount of patience in supporting the venue during these discussions from start to date and are frustrated that the PLH has decided to discontinue contact with TVP. Therefore TVP have no option but to invoke its enforcement policy in order to ensure that a busy Town Centre Night Club is a fit and proper venue for members of the public to enjoy.

TVP have looked at the steps open to the Sub-Committee and considered them in isolation:

- a. To modify the conditions of the Premise Licence.
 - TVP have produced a set of conditions which are proportionate in that they support the licensing objectives which in essence had been accepted by the PLH but with some dispute on three of them that couldn't be resolved.
- b. To suspend the licence for up to a maximum of three months.
 - TVP are requesting a two month suspension of the premise licence in order that there is a clear understanding of the proposed conditions and that a clear managerial regime is established which permits the running of a licensed premise in a safe and responsible manner.
 - There has been a recent change to the DPS which has not been contested by TVP.
 - TVP are not seeking the removal of the current DPS so long as the current licence conditions and the proposed licence conditions are complied with.
 - Revocation of the premises licence is an option but TVP are only requesting a suspension in order that the proposed condition are added to the premises licence and are clearly understood by the management of the premises.

Please receive this letter as a formal request from the Thames Valley Police for the production of CCTV footage from all cameras in the premise for the following dates and times:-

Saturday 4th October 2014, 0230 - 0415

Sunday 5th October 2014, 0300 - 0415

Also we are requesting the door book covering both dates and you will need to contact the Council for a replacement book once this has been provided to us.

The above requests are made as Police are currently investigating issues of disorder both inside and outside of your venue throughout the previous weekend, and also concerning serious issues of crowd control outside of the premise caused by your customers.

Also we have serious concerns over the promotion you are running this Friday and the ability of your venue, security and management to control your client base

It has been proven as of last week that our historical concerns regarding serious crowd control and disorder issues caused by your venue are not unfounded, and we would recommend you seriously consider either withdrawing the promotion or closing the venue this weekend. We suggest this would enable you to look at future strategies which can be put into place to ensure the future safety of members of the public coming into the town and visiting your venue.

Please be reminded of your obligations within the Licensing act as to the objectives relating to the prevention of crime and disorder as well as that of public safety.

I must further draw your attention to condition 7 of page 8 on your License relating to crime and disorder which requires the provision of a risk assessment for "high risk" events 7 days prior to the commencement of the event. A risk assessment for this weekend's promotion has not been provided.

Finally please see condition 4 from page 9 of the License as agreed with Thames Valley Police on 30/06/2010, relating to the provision of a clubscan device. Current intelligence suggests that the system has been out of working order for many months, if not years. This alone in itself negates the caveat of the condition which allows the venue to operate if "the device is not working through no fault of the premises licence holder provided that arrangements are made for the club scan device to resume working at the earliest opportunity"

We strongly urge you to adhere to our recommendations within this letter and confirm that if you operate this weekend without the following conditions mentioned above being complied with; then as the Licence conditions are in breach action will be taken.

Item 1

Welcome and Purpose of Meeting

Simon Wheeler welcomed to the meeting. Introductions were done.

Simon advised he believes this will be a straightforward meeting regarding licensing and premises'. Simon reviewed the process and history of meetings that have been held with the Club. The first tier stages have been progressed and we are now in the final tier.

We are going to put forward measures to address the issues and if possible we can agree today. If more time is needed, 48 hours to come to an agreement will be given. After 48 hours, the Council Licensing Committee will need to adjudicate between us.

Mike King advised the review of the premises is the last resort. We are not at that stage yet and hope to come to an agreement instead advised Simon Wheeler.

Item 2 Review of Issues

Simon asked about seizing a door book, 4 and 5 October Incident. When looking through the book, there was one gentleman who does not work regularly, Sevan Kamack, door book start 3 August 2013 and seized on 4 October. He is signed in 33 times during this period. Who was he employed by? Sarah advised there was a dual employment. We inherited the contact last September. He worked for us then he left. When Ahmed left Zeus Sevan came in. There would have been a gap in the door log when he (Sevan) left.

12/10/13 he works solidly. Then gap until May 2014 advised Simon. Who employed him after that time? Simon asked.

We employed him through the company and he worked for us, then he left about 6-7 months. Then we didn't have doorman at the door and we asked him to do this and it was a short time maybe 2 weeks. There was a misunderstanding and he left advised Kenan. Simon confirmed that accounts for the time period.

If a door supervisor is applied for a venue, a member of the venue has to have a relevant SIA accreditation. During the period, who at the venue had the correct SIA badge? Simon asked. He told us he had the license advised Kenan. 30 May – 28 of June are the dates we are asking about Simon asked. Who had the SIA badge at that time? Simon asked Kenen said he couldn't confirm it now.

Ahmet Unlucomert: Kenen advised he is a bar manager. He was given an SIA badge back advised Simon and he signs in on 8 occasions. Simon gave dates listed in book. Sarah advised he may have signed himself in as the duty manager and he was not paid or engaged by us. Who at the venue was providing the badge to allow him to be employed at that capacity asked Simon. He was controlling the bar and he maybe, not sure, if the door staff didn't turn up he might have done it. Simon showed the log which included the signing of his name and number. Adonis advised we do not know when the document was signed. Simon reviewed the signing along with others in the book. Simon offered the book to be reviewed by Sarah, Kenan and Adonis.

Simon Wheeler reviewed document entitled 'Zeus Chronology' starting 6th August 2012. Kenan confirmed dates he took over Zeus as some of the dates where not in this time period. Simon confirmed the letter and information would have been held by the Club previous owner to new owners. September/October 2013 is when we took over confirmed Sarah. Simon also included Risk Assessments that were done during this period. Simon also reviewed emails from inspectors who raised issues with Zeus and police (as referenced in the chronology). Simon asked about the control with regard to who is making decisions and why it does not get done. Facebook pages shown by Simon to Sarah, Kenan and Adonis – in relation to alcohol use and promotion.

Drunk in Love Promotion:— Selling and supplying alcohol promotion licensing guideline which started on 6 April 2010 was reviewed by Mike King. The facebook page was shown by Simon for this promotion.

Simon asked for history of those banned from working on doors. Sarah gave a brief overview of issues and recently Mr. Francis and his friends have caused problems including serious injury to someone's head. They have cause problems in other Reading venues and we put a ban on them. The previous head door staff at the Purple Turtle let them in. They did not go to the others though. Mr. Francis also demanded money and threatened a door supervisor. This supervisor was moved due to his safety and went to work in Oxford. It puts undo stress on the venue which we do not want. We have dealt with the Turtle's supervisor who is no longer employed as of last week.

What support have you had from Zeus with regard to bans? Simon asked Sarah. Ginge and his lot have not created a massive problem in the venue and it was only recently they were banned and it was enforced. Mr. Francis – his ban was ignored and we bought in our head door supervisor – I provided you the minutes of that meeting. The new supervisor is paid by the venue but we manage him and is employed by us. The week before he was due to start, I went to the venue and we were going to do 100% search (soft launch). We went down through it – including dress code and searching and told them it would be a full policy next week. They were to advise the customers no ID no entry the next week as well. He got upset and agitated when asked about being search. He emptied his pockets on the table and no one could touch him. He left the venue and was allowed back in and threatened the supervisor. We felt it was best to get the door supervisor out of the way – he is no longer in Reading so he does not have to go through this again.

2 September meeting – reviewed notes by Simon. Simon asked for confirmation regarding who is and who is not employed by Sarah's company. Sarah advised we get our staffing quota from Zeus but sometimes the planning isn't there. Sometimes we get a staffing order and get a request for more door staff at night (10pm/midnight). The quality of door supervisors will go down and then we have to look at who else we can redeploy in other areas. The nights that have been busier than anticipated and we have people from other venues but they are not part of us and not paid by us. We have door supervisors working under our banner but not ours and this is an issue for us.

Confidential Page 3

Adonis left the meeting for a short period to take a phone call.

Latest meeting 7th of October - reviewed by Simon.

Adonis returned.

Sarah advised, in relation to the meeting of the 7th of October, the issue of the head door supervisors and venue management having the same understanding which is why we met. Sarah advised we have had a concern with letting individuals in despite the fact it was made clear they are not allowed to come into them.

On 10th October we had a report from a police officer – Simon reviewed the report. This indicated people were being ejected. Some of them requested the manager, peck her on the cheek then be allowed back into the Club. Simon asked why. Kenan advised he did not have a problem like that before. Simon advised this is a problem over a long period of time. This is a serious issue for the Club management.

Chodosy Prince Noduzo – is he a toilet attendant? On 1 November 2014 he was sited for urinating on a wall outside advised Simon. He laughed when challenged by police.

<u>Item 3</u> Recommendations

Summary of concerns by Simon:

- · High risk events of high risk nature
- Management not taking advise from police or door companies
- Lateness of problems at venue (past 4:30am)
- Manager who overrules the door team
- Manager runs promotions like Drunk in Love
- People with badges that are revoked and still working there
- Concerns owner is not aware of details of what is going on
- Suitability of ability to run venue

Licensed conditions to address above is what needs to happen advised Simon.

Mike King reviewed GEN40 with Adonis, Kenan and Sarah. Nightsafe meetings review the GEN40's weekly. Mike gets asked to review issues and find solutions to address them.

Mike handed copy of recommendation to Adonis, Kenan and Sarah.

Included in document which was reviewed by Simon:

- New CCTV condition
- Door supervisor condition (venue has not been running enough of them). Requesting 7 now.
- 100% search policy (issue with drugs being allowed into the venue). They were taking drugs outside the venue advised Kenan.
- Dispersal policy (Mike King offered to give a copy of one that works well).
- Last entry for everyone at 1am. Kenan advised that will cause a problem for us because our customers come in between 1am and 3am and will have a negative impact on our finances (ability to make money).
- What about re-admissions? Sarah asked. Adonis asked about the evidence with people coming in after 1am and point of entry does not seem to be an issue.

She was able to gain access to the venue using a ticket in a different name to that shown on her (borrowed) ID and was not challenged at all by door staff. Whilst inside the venue, she was able to consume both a large amount of alcohol bought over the bar, and MDMA. When leaving the venue, she was barely able to walk and highly disorientated. She was gurning her jaw and clearly highly vulnerable, in the company of a male who himself was also highly under the influence of MDMA. At no time did door staff intervene with the female or raise concerns to police, street pastors or ambulance.

PC 975 LAMPARD was OIC for the incident. As detailed in the occurence, a significant amount of police time and resources were taken up in dealing with Anna. She was conveyed to the RBH and police remained with her until her parents were awoken by a local unit and attended the RBH to take over. The passport used to gain access was seized by police.

Officers entrered the premise to find around 40 Asian males in the VIP area arguing and several squaring up to one another, there had clearly been some king of dispute between the two perties. They were escorted outside the venue and moved along Hosler St to the Butts. It was overheadr whilst doorstaff were assisting with this a remark that then venue "hadn't called the Police" (thereby implying that we had made them close. Fortunately nothing resulted from this comment, but it was untrue). The group loitered in the Butts until eventually thinning out by walking off or leaving in texts. A sizable Police presence was required to prevent further disorder for around 30 minutes

1. A CCTV system shall be installed, in accordance with current or amended Home Office Guidelines relating to UK Police Requirements for Digital CCTV Systems. The system shall be maintained and operated correctly to the satisfaction of Thames Valley Police, (TVP) ensuring ALL licensed areas of the premises (except toilet facilities) are monitored, including all entry and exit points enabling frontal identification of every person entering and in any light condition.

All cameras shall continually record whilst the premises are open to the public and the recordings shall be kept and available for a minimum of 31 days with time and date stamping and except for mechanical breakdown beyond the control of the proprietor shall be made available upon request to the police and authorised officers of the council. Any breakdown or system failure will be notified to the police immediately and remedied as soon as practicable. Any request from (TVP) or Reading Borough Council (RBC) for a recording to be made for evidential purposes must be carried out immediately.

Recordings shall be made available to an authorised officer of Thames Valley Police or an authorised officer of RBC together with facilities for viewing with immediate access by a person qualified to operate the system.

The recordings for up to the preceding two days shall be made available immediately on request. Recordings outside this period shall be made available upon 24 hours notice. A sign advising customers that CCTV is in use shall be positioned in a prominent position. A fully trained person who can operate the system shall be available at all times when the premises is open to the public.

2. A minimum of **7** SIA registered Door Supervisors shall be present whenever the premises are being used under the terms of the license from 9:00pm until closing.

A register of Door Supervisors shall be kept. The register must show the following details:

- Full SIA registration number.
- Date and time that the Door Supervisor commenced duty, countersigned by the Designated Premises Supervisor or Duty Manager.
- Date and time that the Door Supervisor finished work, countersigned by the Designated Premises Supervisor or Duty Manager.
- Any occurrence or incident of interest involving crime & disorder or public safety must be recorded giving names of the Door Supervisor involved.
- A record of the number of patrons on site must be made hourly in the door register.

The Door Supervisor register shall be kept at the premises and be available for inspection by an authorised officer of TVP, or an authorised officer from RBC and shall be retained for a period of one year.

Door Supervisors shall be clearly identifiable at all times whilst on duty and display Hi-Visibility personalised armbands containing their SIA badge.

3. The Licensee must implement an 100% search procedure for all patrons, and provide a written policy agreed with Thames Valley Police, to prevent lilegal weapons and drugs being brought onto the premises, including search, detection, confiscation, storage and disposal of drugs procedures.

Notices shall be displayed advising the public that the right to conduct an outer body search is reserved as a condition of entry, and that the TVP shall be informed if anyone is found in possession of illegal drugs or offensive weapons.

The venue shall also actively partake in drugs initiatives run by TVP (including, but not exclusively, drug itemiser, passive drug dogs and spiked drinks campaigns).

- 4. A closure and dispersal policy, agreed with TVP, for controlling the closing of the premises and the departure of customers at the conclusion of the licensed activities shall be put in place and shall be actively operated.
- 5. No new customers shall be permitted entry to the premise after 01:00hrs.
- **6.The Premises Licence** Holder shall participate, as far as is practicable, in the Local Town Radio Scheme when the premises are opened for licensable activities after 2100hrs Monday to Sunday inclusive.
- 7. The premise shall at all times operate a challenge 25 policy to prevent any customers who attempt to purchase alcohol and who appear to staff members to be under the age of 25 years without having first provided identification.

Only a valid British driver's licence showing a photograph of the person, a valid passport or proof of age card showing the "PASS" hologram are to be accepted as identification. Notices advertising the Challenge 25 and proof of age policies shall be displayed in prominent positions on the premise.

- 8. The Designated Premise Supervisor must ensure that all staff shall be trained in procedures to ensure that no underage drinking occurs on the premises, Signed training records must be kept and immediately made available on request to an authorised officer of TVP or an authorised officer of Reading Borough Council, these records shall be kept for a minimum of 1 year.
- 9. The Designated Premises Supervisor shall ensure on any day when regulated entertainment is provided at the premises after 2100hrs that all new customers entering the premises shall have their details verified by a Club Scan device. The device shall record the names and dates of birth of all persons entering the club and retain the image and detail of the ID presented. This should record the date and time of entry for each ID scanned for a period of no less than 31 days.
- 10. An event management plan for each event shall be available to TVP and RBC, setting out how the event will be managed and the precautions which have been taken to cater for all reasonably foreseeable contingencies, and which will demonstrate the procedures, roles and specific responsibilities of the management team, security and associated personnel. The finished version of such a plane must be available at least 7 working days prior to commencement of the event.
- 11. Alcohol shall cease to be sold at 02.30 a.m.
- 12. All drinks shall be served in polycarbonate containers. No glass shall be used at all during events and drinks in glass bottles shall be decanted into polycarbonate containers.
- 13. Recorded music shall be reduced to background level from 02.00 a.m.
