To confirm the Minutes of the meetings of Licensing Applications Sub-Committee 2 held on 26 January 2017 and Licensing Applications Sub-Committee 1 held on 7 February 2017 as correct records.

3. APPLICATION FOR THE VARIATION OF A PREMISES LICENCE - THE VICTORIA PUBLIC HOUSE, NORCOT ROAD, TILEHURST, READING

To consider an application for the variation of a Premises Licence in respect of the Victoria Public House, 1 Norcot Road, Tilehurst, Reading.

Present: Councillors Livingston (Chair) and Vickers.

20. APPLICATION FOR THE REVIEW OF A PREMISES LICENCE - READIPOP FESTIVAL, CHRISTCHURCH MEADOWS, CAVERSHAM, READING

The Head of Planning, Development and Regulatory Services submitted a report on an application by Reading Borough Council Environmental Protection and Nuisance Team for a review of the premises licence in respect of Readipop Festival, Christchurch Meadow, Caversham, Reading.

The report stated that the Reading Borough Council Environmental and Nuisance Team had submitted the review of the Premises Licence, outlining ten complaints that had been received from residents regarding noise from music being played at the event as well as noise from the fairground. The report also stated that a number of conditions contained on the premises licence were also breached and that there was a general lack of understanding of how to comply with these conditions.

The application sought for conditions on the premises licence to be amended and for new conditions to be applied and further, pursuant to section 177A Licensing Act 2003 the disapplication of conditions relating to noise attached to the premises licence.

A copy of the review application was attached to the report at Appendix RF-1.

The report stated that three representations had been received from local residents, which were attached to the report at Appendix RF-2a, RF-2b and RF-2c.

A plan showing the location of the premises and surrounding streets was attached to the report at Appendix RF-3.

Further to the report, the Event Application Form and a response to the review from the Premises Licence Holder had been circulated.

The report stated that the Premises Licence Holder was Readipop Limited and the Designated Premises Supervisor was Mr Mark Copley. The current Premises Licence, a copy of which was attached to the report at Appendix RF-4, permitted the following:

Hours for the Performance of Plays, Exhibition of Films, Indoor Sports, Performance of Live Music, Playing of Recorded Music, Performance of Dance, Sale of Alcohol and

Friday and Saturday 1100 hours until 2300 hours Sunday 1100 hours until 2100 hours

Hours the Premises is Open to the Public

Friday and Saturday 1000 hours until 2330 hours Sunday 1000 hours until 2130 hours

The premises licence was limited to one event per year which was to be notified to the Licensing Authority 28 days before the event started.

The premises still benefited from the exemption to play live music between 0800 hours and 2300 hours as per the provisions in the Live Music Act 2012 and the exemption for noise conditions stated at Section177A of the Licensing Act 2003.

The report stated that in determining the application the Licensing Authority had a duty to carry out its functions with a view to promoting the four licensing objectives, as follows:

- The prevention of crime and disorder
- public safety
- The prevention of public nuisance
- The protection of children from harm

The report stated further that in determining the application the Licensing Authority must also have regard to the representations received, the Licensing Authority's statement of licensing policy and any relevant section of the statutory guidance to licensing authorities. Further, in determining the application the Licensing Authority could take such of the following steps as it considered appropriate and proportionate for the promotion of the licensing objectives:

- Take no further action
- To issue formal warnings to the premises supervisor and/or premises licence holder
- Modify the conditions of the licence (including, but not limited to hours of operation of licensable activities)
- Exclude a licensable activity from the scope of the licence
- Remove the designated premises licence supervisor
- Suspend the licence for a period not exceeding three months
- Revoke the licence

(Where the Sub-Committee took a step mentioned in the third and fourth bullet points above it may provide that the modification or exclusion was to have effect for a period not exceeding three months or permanently.)

The report set out paragraph 2.14 of the Secretary of State's Guidance, Section 182 of the Licensing Act 2003 (March 2015), which stated that the Act enabled licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It was therefore important that, in considering the promotion of the licensing objective of preventing public nuisance, licensing authorities and responsible authorities focused on the effect of the licensable activities at the specific premises on persons living and working in the area around the premises which might be disproportionate and unreasonable.

The report also set out paragraphs 1.5, 1.10, 11.18, 11.20, 15.36, 15.55, 15.56 of the Secretary of State's Guidance, Section 182 of the Licensing Act 2003 (March 2015) and paragraphs 10.5.1, 11.11.2 and 11.11.3 of the Council's Statement of Licensing Policy.

Mr Gavin Lombos, Readipop was present at the meeting and addressed the Sub-Committee and was represented by Mr William Donne, Licensing Consultant, who also addressed the Sub-Committee.

Rebecca Moon and Catherine Lewis, Reading Borough Council Environmental Protection and Nuisance Team, were present at the meeting and addressed the Sub-Committee on the application.

Mr Alan Godfrey, Mrs Lin Godfrey and Mr James McMaster, local residents who had each submitted a valid representation, were present at the meeting and addressed the Sub-Committee.

Resolved -

That having reviewed the Premises Licence in respect of Readipop Festival, and having had regard to the licensing objectives and the oral and written representations made, the Secretary of State's guidance, in particular paragraphs 1.5, 2.14, 11.10, 11.18, 11.20, 15.36, 15.55 and 15.56, and the Council's Statement of Licensing Policy, in particular paragraphs 10.5.1, 11.11.2 and 11.11.3, the Sub-Committee concluded that it would be appropriate and proportionate for the premises licence to remain in force but for new conditions to be added and for some current conditions to be amended.

That the following current conditions be amended and attached to the licence as follows:

- (a) Current condition 1 be amended to The control limits set at the mixer position shall be adequate to ensure that the music noise level shall not at any noise sensitive premises exceed 65 dBA over a 15 minute period throughout the duration of the licensable activities involving music. If there are more than 3 such licensable activities during the year, a lower limit of 62 dBA shall be in place;
- (b) Current condition 8 be amended to In advance of licensable activities involving music, such activities shall be notified to local residents via written notice which shall include a contact name and telephone number via which complaints about noise can be made on the day of the event. During operating hours, the licensee or nominated representative shall be available to receive and respond to nuisance related complaints. The contents of the notice and the area to be covered shall be agreed with the Reading Borough Council Environmental Protection and Nuisance Team prior to the notice being delivered to residents.

That the following new conditions be attached to the licence as follows:

- (c) Prior to each year's licensable activities involving music, the licensee shall carry out a noise nuisance risk assessment as part of the selection of acts and music genres. This risk assessment shall take into account the low frequency content of the music and other factors likely to cause annoyance, the timing, the duration and the programming of each act. The risk assessment shall be submitted to Reading Borough Council's Environmental Protection and Nuisance Team for approval at least four weeks prior to the start of the licensable activities involving music, which shall not take place without the approval being in place;
- (d) No activity involving funfair rides shall be permitted within the western side of the Christchurch meadows area;
- (e) The funfair shall only operate during the permitted hours of the licence;

(f) The festival shall employ a noise management consultant suitably qualified to a standard recognised by the Institute of Acoustics to monitor and report on noise levels and liaise with Reading Borough Council as required in the preparation and during the performance of the licensable activities involving music;

That Section 177A of the Licensing Act 2003 did not apply to conditions 1 to 10 on the current premises licence or to the amended and newly imposed conditions;

The Sub-Committee's reasons were due to the number of complaints received from residents regarding noise nuisance during 2016 and the assurances from the Premises Licence Holder that there would be no more drum and bass music and that the funfair would not take place except within the licensed area and would be limited to children's' rides.

21. MINUTES

The Minutes of the meeting of Licensing Applications Sub-Committee 2 held on 12 January 2017 were confirmed as a correct record and signed by the Chair.

22. APPLICATION FOR GRANT OF A PREMISES LICENCE - SPRINKLES GELATO, LONDON ROAD, READING

The Head of Planning, Development and Regulatory Services submitted a report on an application by AM Estates Limited for the grant of a Premises Licence in respect of Sprinkles Gelato, 120 London Road, Reading.

The application was requesting a premises licence which would permit the following licensable activities:

Recorded Music

Monday to Sunday 0800 hours until 0000 hours

Late Night Refreshment

Monday to Sunday 2300 hours until 0000 hours

Hours Open to the Public

Monday to Sunday 0800 hours until 0000 hours

A copy of the application form was attached to the report at Appendix RF-1.

A representation against the application had been received from a resident and was attached to the report at Appendix RF-2.

The report stated that in considering representations received, the Licensing Authority had a duty to carry out its functions with a view to promoting the four licensing objectives, as follows:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

The report also stated that paragraph 11.4.1 of the Council's Statement of Licensing Policy, regarding licensing hours for Licensed Premises in Residential Areas, stated that in general the Authority would deal with the issue of licensing hours on the individual merits of each application, but that when issuing a licence, stricter conditions were likely to be imposed with regard to noise control in the case of premises that were situated in largely residential areas. In general, public houses located in and catering for residential areas wishing to open beyond 11pm would need to demonstrate clearly that public nuisance would not result from later operation.

The report also stated that the Licensing Act 2003 Section 18 (6) stated that any relevant representation should be considered in the context of the likely effect of the grant of the

premises licence on the promotion of the licensing objectives. Therefore, in the context of the grant of a licence, it was reasonable for the Licensing Authority to base its decision on an application on what the likely effects of granting a licence would have on the promotion of the licensing objectives. The report also set out paragraphs 1.5, 2.14 and 8.33 to 8.39 of the Amended Guidance issued under Section 182 of the Licensing Act 2003 March 2015.

Mr Rashidul Islam, solicitor, and Mr Mohammed Ilyas, both of Sprinkles Gelato, were present and addressed the Sub-Committee on the application.

Resolved -

(1) That, in order to promote the four licensing objectives, and having regard to the oral and written representations made, the Secretary of State's guidance and the section 11.4 and 11.4.1 of the Council's Statement of Licensing Policy, the application in respect of Sprinkles Gelato, London Road, be granted because the Sub-Committee did not consider that granting the application would have an adverse effect on the licensing objectives, in particular the prevention of public nuisance, as follows:

Recorded Music

Monday to Sunday 0800 hours until 0000 hours

<u>Late Night Refreshment</u>

Monday to Sunday 2300 hours until 0000 hours

Hours Open to the Public

Monday to Sunday 0800 hours until 0000 hours

- (2) That the following conditions be attached to the licence:
 - (a) Clearly legible and suitable notices shall be displayed at all exits requesting customers to respect the needs of local residents and to leave the premises and area quietly. After 23.00hrs staff shall be available to ensure that customers disperse quietly;
 - (b) No music or speech shall be relayed via external speakers, other than for events with the prior approval of the licensing authority;
 - (c) Staff, contractors and associated persons must be given adequate training to prevent them causing unnecessary noise when they leave the premises and prominent, clear notices displayed at all points where staff leave the building must instruct them to respect the needs of local residents and leave the premises and the area quietly;
 - (d) During operating hours, the licensee or a nominated representative shall be available to receive and respond to nuisance-related complaints. A contact number shall be readily available to residents upon request;
 - (e) An incident book/register shall be maintained to record all incidents of crime and disorder occurring at the premises. Details of occasions

when the police are called to the premises shall be recorded. This book/register shall be made available for inspection when requested by a Police Officer or an authorised officer of Reading Borough Council at any time during the event;

(f) The Premise Licence Holder shall ensure the premises has a digitally recorded CCTV system and that the cameras shall continually record whilst the premises are open to the public and recordings shall be kept for a minimum of 31 days with time and date stamping. Data recordings shall be made available without undue delay and no later than 24 hours from initial request to an authorised officer of Reading Borough Council or Thames Valley Police, together with facilities for viewing upon request. Recorded images shall be of such a quality as to be able to identify the recorded person.

(Sunday from 1200hrs until 2230hrs)

4. Proposed licensable activities and hours:

The application is for the variation of a premises licence to permit the following licensable activities and timings:

To extend all licensable activities (as listed above) to be permitted from 1100hrs until 0100hrs the following morning on every day of the week with a closing time of 0130hrs.

To permit the premises to sell alcohol from the terminal hour on New Years Eve right through until the opening hours of New Years Day and to remove the non standard timings stated on the premises licence (Bank Holidays/Christmas Eve, etc)

5. Temporary Event Notices

In considering any application the Licensing Authority should be aware of the possible use of Temporary Event Notices to extend entertainment activities, the sale of alcohol or hours of operation. A premises may extend the hours or scope of their operation by the use of Temporary Event Notices. Up to 15 events per year can be held under this provision at a particular premises. These events may last for up to 168 hours provided less than 500 people are accommodated and provided the total number of days used for these events does not exceed 21 per year.

9. <u>Licensing Objectives and Reading Borough Council's Licensing Policy</u> Statement

In considering representations received the Licensing Authority has a duty to carry out it's functions with a view to promoting the four licensing objectives, which are as follows:

- the prevention of crime and disorder;
- public safety
- the prevention of public nuisance
- the protection of children from harm

Any conditions that are placed on a premises licence should be appropriate and proportionate with a view to promoting the licensing objectives. The Licensing Authority can amend, alter or refuse an application should it be deemed appropriate for the promotion of the licensing objectives.

The Council's licensing policy also places an onus on applicant's who wish to open past 11pm to demonstrate how they will mitigate the issues of crime and disorder and potential public nuisance.

Amended Guidance issued under section 182 of the Licensing Act 2003 April 2017

Licensing Objectives and Aims:

1.5 (However) the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work.

They include:

protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises;

Public nuisance:

- 2.15 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.16 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It may include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.
- 2.19 Where applications have given rise to representations, any appropriate conditions should normally focus on the most sensitive periods. For example, the most sensitive period for people being disturbed by unreasonably loud music is at night and into the early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. This is why there is still a need for a licence for performances of live music between 11 pm and 8 am. In certain circumstances, conditions relating to noise emanating from the premises may also be appropriate to address any disturbance anticipated as customers enter and leave.

Steps to promote the licensing objectives:

- In completing an operating schedule, applicants are expected to have regard to the statement of licensing policy for their area. They must also be aware of the expectations of the licensing authority and the responsible authorities as to the steps that are appropriate for the promotion of the licensing objectives, and to demonstrate knowledge of their local area when describing the steps they propose to take to promote the licensing objectives. Licensing authorities and responsible authorities are expected to publish information about what is meant by the promotion of the licensing objectives and to ensure that applicants can readily access advice about these matters. However, applicants are also expected to undertake their own enquiries about the area in which the premises are situated to inform the content of the application.
- 8.39 Applicants are, in particular, expected to obtain sufficient information to enable them to demonstrate, when setting out the steps they propose to take to promote the licensing objectives, that they understand:
- the layout of the local area and physical environment including crime and disorder hotspots, proximity to residential premises and proximity to areas where children may congregate;
- any risk posed to the local area by the applicants' proposed licensable activities; and
- any local initiatives (for example, local crime reduction initiatives or voluntary schemes including local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.
- Applicants are expected to include positive proposals in their application on how they will manage any potential risks. Where specific policies apply in the area (for example, a cumulative impact policy), applicants are also expected to demonstrate an understanding of how the policy impacts on their application; any measures they will take to mitigate the impact; and why they consider the application should be an exception to the policy.
- 8.41 It is expected that enquiries about the locality will assist applicants when determining the steps that are appropriate for the promotion of the licensing objectives. For example, premises with close proximity to residential premises should consider what effect this will have on their smoking, noise management and dispersal policies to ensure the promotion of the public nuisance objective. Applicants must consider all factors which may be relevant to the promotion of the licensing objectives, and where there are no known concerns,

acknowledge this in their application.

- The majority of information which applicants will require should be available in the licensing policy statement in the area. Other publicly available sources which may be of use to applicants include:
- the Crime Mapping website;
- Neighbourhood Statistics websites;
- websites or publications by local responsible authorities;
- websites or publications by local voluntary schemes and initiatives; and
- on-line mapping tools.
- While applicants are not required to seek the views of responsible authorities before formally submitting their application, they may find them to be a useful source of expert advice on local issues that should be taken into consideration when making an application. Licensing authorities may wish to encourage co-operation between applicants, responsible authorities and, where relevant, local residents and businesses before applications are submitted in order to minimise the scope for disputes to arise.
- Applicants are expected to provide licensing authorities with sufficient information in this section to determine the extent to which their proposed steps are appropriate to promote the licensing objectives in the local area. Applications must not be based on providing a set of standard conditions to promote the licensing objectives and applicants are expected to make it clear why the steps they are proposing are appropriate for the premises.

Representations from the police

9.12 In their role as a responsible authority, the police are an essential source of advice and information on the impact and potential impact of licensable activities, particularly on the crime and disorder objective. The police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area5. The police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective, but may also be able to make relevant representations with regard to the other licensing objectives if they have evidence to support such representations. The licensing authority should accept all reasonable and proportionate representations made by the police unless the authority has evidence that to do so would not be appropriate for the promotion of the licensing objectives. However, it remains incumbent on the police to ensure that their representations can withstand the

scrutiny to which they would be subject at a hearing.

Licensing authorities acting as responsible authorities

9.13 Licensing authorities are included in the list of responsible authorities. A similar framework exists in the Gambling Act 2005. The 2003 Act does not require responsible authorities to make representations about applications for the grant of premises licences or to take any other steps in respect of different licensing processes. It is, therefore, for the licensing authority to determine when it considers it appropriate to act in its capacity as a responsible authority; the licensing authority should make this decision in accordance with its duties under section 4 of the 2003 Act.

The Licensing Act 2003 under Section 18 (6) also states that any relevant representation should be considered in the context of:

(a) the <u>likely effect</u> of the <u>grant</u> of the premises licence on the promotion of the licensing objectives.

Therefore in the context of the grant of a licence, it is reasonable for the Licensing Authority to base it's decision on an application on what the <u>likely effects</u> of granting a licence would have on the promotion of the licensing objectives.

The Council's Licensing Policy Statement:

11.4 Licensed Premises in Residential Areas

11.4.1 In general the Authority will deal with the issue of licensing hours on the individual merits of each application. However, when issuing a licence, stricter conditions are likely to be imposed with regard to noise control in the case of premises that are situated in largely residential areas. In general, public houses located in and catering for residential areas wishing to open beyond 11pm will need to demonstrate clearly that public nuisance will not result from later operation.

 - at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- Every supply of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

Film Exhibitions

To be applied only where a premises licence or club premises certificate authorises the exhibitions of films

- 1 The admission of children to any exhibition of any film must be restricted in accordance with section 20 of Part 3 of the Licensing Act 2003.
- In the case of films which have been classified by the British Board of Film Classification admission of children to films must be restricted in accordance with that classification.
- In the case of films which have not been classified by the British Board of Film Classification, admission of children must be restricted in accordance with any recommendation made by the Licensing Authority.

Door Supervisors

To be applied where a premises licence or club premises certificate includes a condition that any person must be at the premises to carry out a security activity. [Except premises with a premises licence authorising only plays or films or premises used exclusively by a club].

Each individual present at the licensed premises to carry out a security activity must be licensed by the Security Industry Authority.

Responsible Drink Promotions (commencement date 01/10/2014)

- The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Supply of Tap Water (commencement date 01/10/2014)

1. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy (commencement 01/10/2014)

- 1. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 2. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Drink Measurements (commencement date 01/10/2014)

- The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

Minimum Permitted Pricing (commencement 28th May 2014)

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1-
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—P = D + (DxV)

where-

(i) P is the permitted price,

(ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994

- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- 4. (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2

Conditions Consistent with the Operating Schedule

General

1. All staff must be adequately trained in procedures to ensure that no underage drinking or drunkenness occurs on the premises.d

Prevention of Crime & Disorder

- 1. All staff must be adequately trained in drug awareness and means to prevent violent and antisocial behaviour.
- The Premises Licence holder must ensure that the Designated Premises Supervisor holds membership of, and actively participates in, the Reading Pub Watch Scheme, including making use of apparatus supplied as part of the scheme.
- 3. The Premises must have installed a CCTV system in accordance with the Association of Chief Police Officers standard, to a specification approved by the Crime Reduction Advisor of the Thames Valley Police. The CCTV system must be effectively maintained and must be operated continually throughout trading hours.

Public Safety

1. The maximum occupancy capacity within the premises should be 100 persons.

Prevention of Public Nuisance

1. All staff must be appropriately trained in procedures to prevent incidents of public nuisance. 2. All windows will be closed and locked from 2200hrs onwards.

Protection of Children from Harm

- 1. Recognised proof of age schemes and/or photo driving licences must be used at the premises.
- 2. Children must only be permitted on the premises over the age of 14 to 17 and only when accompanied by an adult.

Annex 3

Conditions attached after a hearing by the Licensing Authority

- 1. All external doors/windows must be kept closed, other than for access and egress, when events involving amplified music or speech are taking place and where doors and windows must remain shut to ensure neighbours are not disturbed, a suitable ventilation system may be required allowing a minimum of eight air changes per hour and any new plant associated with this system shall be suitably guarded and maintained and should not result in an increase in the background noise level as measured at the nearest noise sensitive premises.
- 2. The licensee shall ensure that no noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to undue disturbance to local residents.
- 3. During operating hours, the licensee or a nominated representative shall be available to receive and respond to nuisance-related complaints and a contact number shall be readily available to residents upon request.
- 4. Clearly legible and suitable notices shall be displayed at all exits requesting customers to respect the needs of local residents and to leave the premises and area quietly and after 2230 hours, staff shall be available to ensure that customers disperse quietly.

I refer to the above application.

I have reviewed the application and consulted our records and would like to make representation against the application. I am concerned that due to the residential location of the premises, there is potential for a public nuisance to occur due to live and recorded music until 1 am and premises opening until 1:30 am every day. There are no measures outlined in section P(d) of the application regarding how public nuisance will be prevented. 1 am is a very sensitive time of the night when the background noise is likely to be low and most surrounding residents will be sleeping. The premises is surrounded by residential properties.

The Reading Borough Council Licensing Policy Statement states that public houses located in and catering for residential areas wishing to open beyond 11pm will need to demonstrate clearly that public nuisance will not result from later operation. In this case I do not believe that the applicant has demonstrated this to be the case - no measures have been proposed at all.

The main areas of concern are:

- Break out of music noise (live and recorded) from the premises
- Noise from the outdoor area and smokers
- Noise from people leaving the venue at the end of the night

The current noise control conditions on the premises licence are as follows in italics, however I do not believe that these are sufficient to prevent public nuisance from the proposed extended hours of opening and of music. There may well be break out of music noise even with doors and windows closed, which is indicated by complaints received in 2009 about loud music regularly coming from the pub. In addition the current conditions do not

control noise from the beer garden, and it is difficult to control noise from patrons leaving the premises late at night.

- 1. All external doors/windows must be kept closed, other than for access and egress, when events involving amplified music or speech are taking place and where doors and windows must remain shut to ensure neighbours are not disturbed, a suitable ventilation system may be required allowing a minimum of eight air changes per hour and any new plant associated with this system shall be suitably guarded and maintained and should not result in an increase in the background noise level as measured at the nearest noise sensitive premises.
- 2. The licensee shall ensure that no noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to undue disturbance to local residents.
- 3. During operating hours, the licensee or a nominated representative shall be available to receive and respond to nuisance-related complaints and a contact number shall be readily available to residents upon request.
- 4. Clearly legible and suitable notices shall be displayed at all exits requesting customers to respect the needs of local residents and to leave the premises and area quietly and after 2230 hours, staff shall be available to ensure that customers disperse quietly.

If the applicant agreed to the inclusion of the following conditions upon the licence, it may be that a limited extension to opening hours, until midnight, could be implemented without a significant disturbance to local residents.

- Live and recorded music shall be reduced to a background level at 11 pm on Monday-Thursday and Sundays and at 11:30 pm on Friday and Saturday.
- The beer gardens shall be cleared of patrons from 11 pm and shall not be used between 11 pm and 11 am.
- The number of smokers permitted outside the premises after 11 pm shall be limited to 3 at any one time and no drinks shall be permitted outside after this time.

If the applicant agreed to the above measures being placed as conditions on the premises licence and the limited extension to the opening hours then I would be willing to withdraw my representation.

Officer comments

In order to promote the four licensing objectives, I object to the application due to the potential undermining of the licensing objectives - notably the prevention of crime and disorder, protection of children from harm and the prevention of public nuisance. I believe that the operating schedule contained within the application does not include suitable measures to promote the licensing objectives. I refer to Section 18 (6) of the Licensing Act in regard to the likely effect the granting of a licence would have on the promotion of the licensing objectives and sections 8.33 to 8.41 of the Secretary of State's Guidance which deals with the information that applicants should provide to the licensing authority in order to actively promote the licensing objectives. I believe the information included in the application does not assist in both of these regards and require the additional conditions to be attached to any premises licence that may be granted. Together with recent evidence that premises which allows children access are being used for illegal (class A) drug use which I would suggest, seriously undermines the above mentioned licensing objectives.

Additionally, in line with other nearby licensed premises located in residential areas, all licensable activities to cease at midnight.

Reading Borough Council Licensing Policy statement states:

Licensed Premises in Residential Areas

In general the Authority will deal with the issue of licensing hours on the individual merits of each application. However, when issuing a licence, stricter conditions are likely to be imposed with regard to noise control in the case of premises that are situated in largely residential areas. In general, public houses located in and catering for residential areas wishing to open beyond 11pm will need to demonstrate clearly that public nuisance will not result from later operation.

Licence Conditions

General Approach to Licence Conditions

The purpose of the licensing Act is the regulation of licensable activities on licensed premises. All conditions attached to Premises Licences and Club Premises Certificates, will be focused on matters, which are within the control of individual licensees and others in possession of relevant authorisations. Accordingly, matters will centre on the premises being used for licensable activities and the vicinity of these premises.

Licensing law is not the primary mechanism for the general control of nuisance and anti-social behaviour once persons are away from licensed premises, and therefore, beyond the direct control of the individual, club or business holding the licence, certificate or authorisation. However, licensing law will always be part of a holistic approach to the management of the evening and local economy.

Licensing conditions will relate to licensed premises and the impact of those licensable activities on the premises in the vicinity thereof. In this latter regard the Council will primarily focus on the direct impact of any activities taking place on those living, working or otherwise engaged in the area concerned business, which is a relevant representation, or conditions are consistent with the operating schedule submitted by the applicant.

The Authority will, only impose conditions on premises if it is considered necessary and proportionate to do so in order to promote the licensing objectives. The Authority does not propose to implement standard conditions on licences across the board but instead, will draw upon a pool of conditions based upon those issued by the Home office and will attach such other conditions as it considers appropriate, given the circumstances of each individual case.

The model conditions will cover issues surrounding;

crime and disorder

public safety

public nuisance

protection of children from harm

Conditions to be imposed on licences will be tailored to the individual premises and events concerned. None of the matters discussed within this policy which may result in the imposition of conditions will be applicable or suitable for all premises. The Authority will have regard to the size and type of premises when considering imposing conditions upon licences as the result of receiving relevant representations.

Applicants are asked to consider the model conditions and incorporate such of the

conditions into their operating schedules as they consider appropriate and necessary in order to promote the licensing objectives. The Authority will impose the model conditions on application when those conditions are consistent with the operating schedule.

- 1. The premises shall at all times operate a Challenge 25 policy to prevent any customers who attempt to purchase alcohol and who appear to the staff member to be under the age of 25 years from making such a purchase without having first provided identification. Only a valid driver's licence showing a photograph of the person, a valid passport or a nationally approved proof of age card showing the 'Pass' hologram, or military id card (or any other similarly nationally recognised scheme), are to be accepted as identification.
- 2. Notices advertising the Challenge 25 age verification policy shall be displayed in prominent positions on the premises.
- 3. Staff employed to sell alcohol shall undergo training upon induction in utilising the Challenge 25 proof of age checking policy. This shall include, but not be limited to, dealing with refusal of sales, proxy purchasing and identifying attempts by intoxicated persons to purchase alcohol. Such training sessions are to be documented and refreshed every six months. All training sessions are to be documented in English. Records of training shall be kept for a minimum of one year and be made available to an authorised officer of Thames Valley Police and Reading Borough Council upon request.
- 4. An incident log shall be maintained to record all incidents of crime and disorder occurring at the premises. Details of occasions when the police are called to the premises shall be recorded. This log shall be available for inspection by a Police Officer or an authorised officer of Reading Borough Council upon request and shall be retained for one year. The log shall be signed off by the Designated Premises Supervisor (DPS) or nominated representative at the end of each trading session. A weekly review of the incident register shall also be carried out by the Designated Premises Supervisor.
- 5. All cashiers involved in the sale of alcohol shall be trained to record refusals of sales of alcohol in a refusals log (whether written or electronic). The log shall contain:
- Details of the time and date the refusal was made;
- The identity of the staff member refusing the sale;
- Details of the alcohol the person attempted to purchase.

This log /register shall be made available for inspection by a police Officer or authorised officer of Reading Borough Council upon request.

6. The Premises Licence Holder shall ensure that a system of preventing drinks being taken from the building by customers other than to the beer garden or other enclosed area is adopted and maintained. The Premises Licence holder shall prevent customers from leaving the premise with any alcoholic or non alcoholic drinks from the Premises in open containers (e.g. glasses, opened bottles & cans).

- 7. Children shall only be permitted on the premises when accompanied by a responsible adult. No children shall be permitted on the premises after 20.00 hours.
- 8. The last permitted first entry time to the premises on any given night shall be 23.00 hours.

If the applicant agrees to the above measures being placed as conditions on the premises licence and the reduced operating hours I would be willing to withdraw my representation.

On 26th April 2017 Thames Valley Police (TVP) were made aware of an application to vary the hours of operation for the sale of alcohol from the current 23.30 p.m. to 01.00 a.m. The premises is surrounded on three sides by high density residential housing which potentially could be subjected to disturbance and disruption due to the increase in the permitted licensable activity.

In looking at the application which include Live Music, Recorded Music, Performance of Dance, and Anything of a Similar Description to That Falling within e, (f), or (g), all until 01.00 a.m. one can only conclude that there is going to be an increase in noise pollution along with that of arriving and departing customers in the early hours.

There are, in walking distance, a further three Public Houses local to the premises whose alcohol sales in two are restricted until Midnight and the other to 23.00 p.m. Overall TVP have not been made aware of any public nuisance issues.

It is pertinent to mention that the premises has been subject to a hearing by the Licensing Authority following noise issues at the venue and the Licensing Panel found it prudent to attach four conditions to address the problems that have been experienced by local residents.

In addition, on the 9th June 2016 an intelligence submission was made to the Police advising that the new DPS was letting in individuals who had been previously barred by the previous incumbent due to their behaviour, this despite being advised of them by the regulars attending the venue. The submission further advises that it is believed that some of these individuals are dealing in drugs. The premises has been swabbed for drug usage with positive results, in most cases this has been Cocaine usage with 50% of the readings being Medium to High.

Incidents that have been recorded by TVP going back to January 2014 to date, these include incidents from Intelligence Reports, Command & Control and the Occurrences from the crime data base will be submitted in due course when the redaction process of sensitive data has been completed.

In one document it suggests that underage children were in the venue contrary to Condition 2 of the Protection of Children section of the Annex 2 Conditions. The document also advises that they were becoming intoxicated as adults were buying alcohol for them a clear breach of the Licensing Act 2003.

TVP has been advised that Reading Borough Council's Environmental Services and the Licensing Department are also submitting similar representations to the application. It has had sight of the licensing submission and fully supports its contents. In addition, TVP wish to update the CCTV Condition attached to the Premises Licence, and include a Drugs, Search and Dispersal Condition to the current Premises Licence.

This representation is submitted in support of the four Licensing Objectives.

In addition TVP would seek that the following proposed conditions are attached to the premises licence.

Prevention of Crime and Disorder

CCTV

The current CCTV system shall be maintained and operated correctly to the satisfaction of Thames Valley Police, (TVP) ensuring ALL licensed areas of the premises (except toilet facilities) are monitored, including all entry and exit points enabling frontal identification of every person entering and in any light condition.

All cameras shall continually record whilst the premises are open to the public and the recordings shall be kept and available for a minimum of 31 days with time and date stamping and, except for mechanical breakdown beyond the control of the premises licence holder, shall be made available upon request to the authorised officers of (TVP) Reading Borough Council (RBC). Any breakdown or system failure will be notified to the Police immediately and remedied as soon as practicable. Any request from (TVP) or (RBC) for a recording to be made for evidential purposes must be carried out immediately.

The recordings for up to the preceding two days shall be made available immediately on request. Recordings outside this period shall be made available upon 24 hours notice. A sign advising customers that CCTV is in use shall be positioned in a prominent position. A fully trained person who can operate the system shall be available at all times when the premises is open to the public.

Drugs Initive

The Premises Licence Holder shall implement an active policy, agreed with TVP, to prevent illegal weapons and drugs being brought onto the premises, including search, detection, confiscation, storage and disposal of drugs procedures.

The venue shall also actively partake in drugs initiatives run by TVP (including, but not exclusively, drug itemiser, passive drug dogs and spiked drinks campaigns).

Search Policy

Notices shall be displayed advising the public that the right to conduct an outer body search is reserved as a condition of entry, and that the TVP shall be informed if anyone is found in possession of illegal drugs or offensive weapons.

Dispersal Policy

A closure and dispersal policy, agreed with TVP, for controlling the closing of the premises and the departure of customers at the conclusion of the licensed activities shall be put in place and shall be actively operated.
