- 1. PURPOSE OF REPORT AND EXECUTIVE SUMMARY
- 1.1 The purpose of this report is to seek approval from the Committee, acting as shareholder of Reading Transport Ltd, for the appointment of Mr Robert Williams to the role of Chief Executive Officer of Reading Transport Ltd.
- 1.2 The Chair of the Committee was of the view that consideration of this item was a matter of urgency as defined in section 100B (4)(b) of the Local Government Act 1972 (as amended), and should be considered at this meeting because of the need for the shareholder to consider confirming the appointment to the post of Chief Executive of Reading Transport Limited as soon as possible, and should not be delayed until the next available meeting on 24 September 2018.

2. RECOMMENDED ACTION

2.1 That the Committee approves the appointment of Mr Robert Williams to the role of Chief Executive Officer of Reading Transport Ltd, commencing on 1st October 2018.

3. POLICY CONTEXT

- 3.1 The Council is the shareholder of Reading Transport Ltd. The relationship between the Council as shareholder and the Board is set out in the company's Articles of Association, which were authorised by the former Transportation Committee of the Borough Council on 21 February 1986 (Minute 190 refers).
- 4. THE PROPOSAL
- 4.1 Following a comprehensive recruitment and selection process, Mr Robert Williams was identified as the preferred candidate for the role of Chief Executive Officer of Reading Transport Ltd.

- 4.2 Mr Williams is currently the Commercial Director of Stagecoach South West. It is recommended that the Committee, acting as shareholder of Reading Transport Ltd, approves the appointment of Mr Williams to the role of Chief Executive Officer of Reading Transport Ltd, commencing 1st October 2018.
