### 3. APPLICATIONS FOR THE GRANT, RENEWAL, SUSPENSION OR REVOCATION OF HACKNEY CARRIAGE AND PRIVATE HIRE VEHICLE DRIVER LICENCES AND APPEALS AGAINST THE ALLOCATION OF PENALTY POINTS ON PRIVATE HIRE VEHICLE DRIVER'S LICENCE

The Executive Director of Economic Growth and Neighbourhood Services submitted a report asking the Sub-Committee to consider an application for the grant of a Private Hire (School Transport) Vehicle Driver's Licence, the suspension or revocation of a hackney carriage vehicle driver's licence and an appeal against allocation of penalty points on a private hire vehicle driver's licence.

## LICENSING APPLICATIONS SUB-COMMITTEE 3 MEETING MINUTES - 3 AUGUST 2022

  - (a) the nature of the offences, as detailed in the report;
  - (b) breaches of licence conditions, as detailed in the report.

- (3) That the appeal against the allocation of penalty points to the Private Hire Vehicle driver's licence in respect of SMRA be deferred to the meeting of the Sub-Committee on 29 September 2022.
