1. ADMISSION OF HONORARY ALDERMAN OF THE BOROUGH

1. The Mayor will announce that the meeting has been convened to consider the admission of an Honorary Alderman of the Borough.

The Mayor will then invite Councillor Rowland to move the following motion:

“That the Council confers the title of Honorary Alderman, in accordance with section 249 (1) of the Local Government Act 1972 and the criteria approved by the Council on 23rd February 2022, on the following person:

Tony Page, for having rendered eminent service on Reading Borough Council as a member for Abbey ward, including a term as Mayor of Reading and having held senior political office.”

Other Councillors will be invited to speak.

2. The Mayor will take a vote on a show of hands.
3. If the motion is carried, the Mayor will invite Tony Page and the Chief Executive’s representative to sign the Book of Honorary Aldermen and Alderwomen.

9. All other guests will stay seated for a few minutes until invited to leave the Council Chamber via the Rear Doors.
