LICENSING ACT 2003 HEARING FRIDAY 31ST JANUARY 2020 AT 0930HRS (9.30AM)

APPLICATION FOR THE SUMMARY REVIEW OF A PREMISES LICENCE

1. Premises:

Yates

7-9 Friar Street

Reading

RG1 1DB

2. Applicants Requesting Review:

Thames Valley Police

3. Grounds for Review

The application for a summary review has been submitted on the grounds outlined within the application and accompanying certificate. The certificate states that the premises has been associated with serious disorder. Two incidents are particularly noted. One on 01/01/2020 where a fight broke out about 0205hrs on the first floor that was not able to be contained or deescalated by the premises security and resulted in police officers having to enter the premises. This later resulted in 20 police officers forming a police line to disperse the crowd. Further to this, another incident of mass disorder occurred on 04/01/2020 about 2100hrs involving about 150 people. Police officers were once again required to deescalate the situation by forming a police line to assist dispersal.

The review application has been submitted to prevent further undermining of the licensing objectives of 'Prevention of Crime and Disorder', 'Protection of Children from Harm' and 'Public Safety'.

4. Date of receipt of application: 06th January 2020

A copy of the review application received is attached as Appendix RS-1

On **08/01/2020** a meeting was convened where the Licensing Committee determined that interim steps were necessary to be put in place immediately. The interim step imposed was for immediate suspension of the licence. A copy of the committee minutes are attached as **Appendix - RS-5**

5. Date of closure of period for representations: 20/01/2020

6. Representations received:

A representation was received from Reading Borough Council's Licensing department. This is attached as **Appendix RS-3**

7. Background

This premises is located on Friar Street near St Laurence's Church and is within the Council's Cumulative Impact Area.

The Premises Licence Holder is stated as: Stonegate Pub Company Ltd The designated premises supervisor is stated as: Mr John Button

The premises currently has the benefit of a premises licence (LMV000356). This is attached as **Appendix RS-2**

8. Licensing Objectives and Reading Borough Council's Licensing Policy Statement

In determining this application the Licensing Authority has a duty to carry out its functions with a view to promoting the four licensing objectives, which are as follows:-

- the prevention of crime and disorder;
- public safety
- the prevention of public nuisance
- the protection of children from harm

In determining this application the Licensing Authority must also have regard to the representations received, the Licensing Authority's statement of licensing policy and any relevant section of the statutory guidance to licensing authorities.

9. Power of Licensing Authority on the determination of a Review

In determining the review application the sub-committee can take such steps as it considers appropriate for the promotion of the licensing objectives, which are:

- 1. Take no further action
- 2. To issue formal warnings to the premises supervisor and/or premises licence holder
- 3. Modify the conditions of the licence (including, but not limited to hours of operation of licensable activities)
- 4. Exclude a licensable activity from the scope of the licence
- 5. Remove the designated premises licence supervisor
- 6. Suspend the licence for a period not exceeding three months
- 7. Revoke the licence.

Where the sub-committee takes a step mentioned in 3 or 4 it may provide that the modification or exclusion is to have effect for a period not exceeding three months or permanently.

In considering the interim steps on receipt of a summary review, the Licensing Authority may consider:

- 1. the modification of the conditions of the premises licence
- 2. the exclusion of the sale of alcohol as a licensable activity

- 3. the removal of the designated premises supervisor
- 4. the suspension of the premises licence

Interim steps were imposed on 08th January 2020. The Licensing Authority must also determine whether these interim steps should remain in force on the date of the full review - in this case 31st January 2020.

Amended Guidance issued under section 182 of the Licensing Act 2003 (April 2018)

Licensing Objectives and Aims:

- 1.2 The legislation provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are undertaken.
- 1.3 The licensing objectives are:
- The prevention of crime and disorder;
- Public safety:
- The prevention of public nuisance; and
- The protection of children from harm.
- 1.4 Each objective is of equal importance. There are no other statutory licensing objectives, so that the promotion of the four objectives is a paramount consideration at all times.
- 1.5 However, the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work. They include:
 - protecting the public and local residents from crime, anti-social behaviour and noise nuisance caused by irresponsible licensed premises

Purpose

- 1.7 This Guidance is provided to licensing authorities in relation to the carrying out of their functions under the 2003 Act. It also provides information to magistrates' courts hearing appeals against licensing decisions and has been made widely available for the benefit of those who run licensed premises, their legal advisers and the general public. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment and proportionality.
- 1.8 The police remain key enforcers of licensing law. This Guidance does not bind police officers who, within the parameters of their force orders and the law, remain operationally independent. However, this Guidance is provided to support and assist police officers in interpreting and implementing the 2003 Act in the promotion of the four licensing objectives.

Summary Reviews:

- 12.1 Summary reviews can be undertaken when the police consider that the premises concerned is associated with serious crime or serious disorder (or both). The summary review process, set out under sections 53A-53D of the 2003 Act, allows interim conditions to be quickly attached to a licence and a fast track licence review. The provisions were inserted by section 21 of the Violent Crime Reduction Act 2006 and amended by sections 136-137 of the Policing and Crime Act 2017, including the addition of section 53D.
- 12.2 The powers apply only where a premises licence authorises the sale of alcohol. They do not apply in respect of other premises licences, or to premises operating under a club premises certificate. The powers are aimed at tackling serious crime and serious disorder, in particular (but not exclusively) the use of guns and knives. The powers complement the general procedures in the 2003 Act for tackling crime and disorder associated with licensed premises and should be reserved for the most serious matters which cannot be adequately or otherwise redressed unless urgent action is taken. Separate powers in the Anti-social Behaviour, Crime and Policing Act 2014 provide for the instant closure of premises by the police in some circumstances (in essence, disorder or nuisance). The consequent review of premises licences by the licensing authority is provided for by section 167 of the Licensing At 2003.
- 12.5 The tests to determine the kinds of conduct that amount to serious crime are set out in section 81(2) and (3) of the Regulation of Investigatory Powers Act 2000. Those tests are that the conduct:
- (a) constitutes an offence for which a person who is 21 years of age or over with no previous convictions could reasonably be expected to be sentenced to imprisonment for 3 years or more; or
- (b) Involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.
- 12.6 There is no definitive list of behaviours that constitute serious disorder, and the matter is one for judgment by the local police. The phrase should be given its plain, ordinary meaning, as is the case under section 12 of the Public Order Act 1986 in which it is also used.
- 12.13 The interim steps that the licensing authority must consider taking are:
- the modification of the conditions of the premises licence;
- the exclusion of the sale of alcohol by retail from the scope of the licence;
- the removal of the designated premises supervisor from the licence; and
- the suspension of the licence.

Modification of the conditions of the premises licence can include the alteration or modification of existing conditions or addition of any new conditions, including those that restrict the times at which licensable activities authorised by the licence can take place.

12.14 If the licensing authority decides to take steps at the initial interim stage:

- the decision takes effect immediately, or as soon after it as the licensing authority directs; but
- the licensing authority must give immediate notice of its decision and its reasons for doing so to the holder of the premises licence and the chief officer of police who made the application. The 2003 Act does not specify that the immediate notice has to be in writing. However, in an individual case the licensing authority may consider that the need for immediate communication at least initially requires a non-written approach, such as a telephone call. This may happen when, for example, the authority decides that the decision should have immediate effect. In such a case, the decision and the reasons for it should be explained clearly and in full to the licence-holder (or someone who may properly act for the licence-holder), and the call followed up as soon as possible with a written version of the decision and the reasons (for example, by email or fax) which is identical to, or not significantly different from, the version given by telephone.
- 12.15 The licensing authority, in deciding when its decision on interim steps should take effect, should consider the practical implications of compliance in relation to the premises. For example, to comply with a modification of the conditions of a licence that requires employment of door supervisors, those running the premises may need some time to recruit appropriately qualified and accredited staff.
- 12.17 The premises licence holder may make representations against the interim steps taken by the licensing authority. There is no time limit for the premises licence holder to make representations on the interim steps, although in practice this would at some point be superseded by the full review which would have to be completed within 28 days of the application being received by the licensing authority. On receipt of such representations, the licensing authority must (if the representations are not withdrawn) hold a hearing within 48 hours of their receipt. When calculating the 48 hour period, any non-working day can be disregarded. Where the licensing authority has already held a hearing to consider representations against the interim steps, the holder of the licence may only make further representations if there has been a material change in circumstances.
- 12.18 The licensing authority must give advance notice of the hearing to the premises licence holder and the chief officer of police. Given that these measures are designed to deal with serious crime and/or serious disorder on an interim basis only, the process is designed to avoid delay and, as such, significant portions of the Licensing Act 2003 (Hearings) Regulations 2005 (SI 2005/44) (which set out the usual processes governing the conduct of licensing authority hearings) do not apply in order to streamline the hearing process. One result of this is that the licensing authority cannot adjourn the hearing to a later date if the licence holder fails to attend at the scheduled time, as is the case under the normal review procedure. And as is the case with that procedure, the licence holder does not have to be present for the hearing to take place. In addition, there is no timescale for notifying the licence holder of the hearing under the modified process, providing the notification takes place before the hearing is held. However, it is imperative that the licence holder be given as much notice as is possible in the circumstances to afford the holder a maximum practicable opportunity to prepare

for and attend the hearing. Licensing authorities should bear in mind that the usual principles of public law decision-making will apply to interim determinations, in a form that has regard to the statutory context of an expedited process.

- 12.19 At the hearing to consider representations against interim steps the licensing authority must:
- consider whether the interim steps are appropriate for the promotion of the licensing objectives; and
- determine whether to withdraw or modify the steps taken.
- 12.20 When considering the case the licensing authority must take into account:
- the senior officer's certificate that accompanied the application;
- the chief officer's representations (if any); and
- any representations made by the premises licence holder.
- 12.21 There is no right of appeal to a magistrates' court against the licensing authority's decision at this stage.

The review of the premises licence under section 53C

12.22 The licensing authority must hold a full review of the premises licence and determine the review within 28 days after the day of receipt of the chief officer's application. There can be no adjournment of the hearing or delay in reaching a determination beyond the end of the 28 day period. This must take place even if the chief officer asks to withdraw his application or representations. At the review hearing, the licensing authority must consider what steps are appropriate for the promotion of the licensing objectives taking into account any change in circumstances since any interim steps were imposed, consider any relevant representations, and review the interim steps already taken (if any).

Review of the interim steps under section 53D

- 12.29 The licensing authority's determination does not have effect until the end of the 21 day period given for appealing the decision, or until the disposal of any appeal that is lodged (see below information on right of appeal). To ensure that there are appropriate and proportionate safeguards in place at all times, the licensing authority is required to review any interim steps that it has taken that are in place on the date of the hearing and consider whether it is appropriate for the promotion of the licensing objectives for the steps to remain in place, or if they should be modified or withdrawn. The review of the interim steps should take place immediately after the determination under section 53C has been reached. In making its decision, the licensing authority must consider any relevant representations made.
- 12.30 In conducting the review of the interim steps the licensing authority has the power to take any of the steps that were available to it at the initial stage (see paragraph 12.13). Any interim steps taken at the review hearing apply until—

- (a) the end of the period given for appealing against a decision made under section 53C (21 days),
- (b) if the decision under section 53C is appealed against, the time the appeal is disposed of, or
- (c) the end of a period determined by the relevant licensing authority (which may not be longer than the period of time for which such interim steps could apply under (a) or (b) above).

Right of appeal against review of interim steps decision

12.31 The licence holder or the chief officer of police may appeal against the decision made by the licensing authority concerning its review of the interim steps to a magistrates' court. The appeal must be made within 21 days of the appellant being notified of the licensing authority's decision and must be heard in full by the magistrates' court within 28 days beginning with the day on which the appellant lodged the appeal.

Protection of children from harm

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.

The role of responsible authorities (eg Police)

9.12 Each responsible authority will be an expert in their respective field, and in some cases it is likely that a particular responsible authority will be the licensing authority's main source of advice in relation to a particular licensing objective. For example, the police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area. The police should usually therefore be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective. However, any responsible authority under the 2003 Act may make representations with regard to any of the licensing objectives if they have evidence to support such representations. Licensing authorities must therefore consider all relevant representations from responsible authorities carefully, even where the reason for a particular responsible authority's interest or expertise in the promotion of a particular objective may not be immediately apparent. However, it remains incumbent on all responsible authorities to ensure that their representations can withstand the scrutiny to which they would be subject at a hearing.

Licensing authorities acting as responsible authorities

9.13 Licensing authorities are included in the list of responsible authorities. A similar framework exists in the Gambling Act 2005. The 2003 Act does not require responsible authorities to make representations about applications for the grant of premises licences or to take any other steps in respect of different licensing processes. It is, therefore, for the licensing authority to determine when it considers it appropriate to act in its capacity as a responsible authority; the licensing authority should make this decision in accordance with its duties under section 4 of the 2003 Act.

<u>Determining actions that are appropriate for the promotion of the licensing</u> objectives

- 9.42 Licensing authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case-by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.
- 9.43 The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.

The review process

- 11.1 The proceedings set out in the 2003 Act for reviewing premises licences and club premises certificates represent a key protection for the community where problems associated with the licensing objectives occur after the grant or variation of a premises licence or club premises certificate.
- 11.2 At any stage, following the grant of a premises licence or club premises certificate, a responsible authority, or any other person, may ask the licensing authority to review the licence or certificate because of a matter arising at the premises in connection with any of the four licensing objectives.
- 11.10 Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for a review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this co-operation.

Powers of a licensing authority on the determination of a review

11.16 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.

- 11.17 The licensing authority may decide that the review does not require it to take any further steps appropriate to promoting the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.18 However, where responsible authorities such as the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate. Similarly, licensing authorities may take into account any civil immigration penalties which a licence holder has been required to pay for employing an illegal worker.
- 11.25 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. There is, therefore, no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.

Reading Borough Council Licensing Policy Statement (2018)

- 1.5 This licensing policy aims to make Reading's night time economy an economy for all. A diverse range of responsibly run premises are to be encouraged. The licensing authority wishes to discourage drunkenness and a move away from alcohol led vertical drinking establishments. We would expect responsibly run premises to actively promote the licensing objectives through promoting extra seating at their premises; instigating effective dispersal from their premises at the conclusion of licensable activities and engagement with the licensing authority and other responsible authorities in policies, initiatives and strategies that promote Reading as a safe, healthy, diverse and vibrant night time economy suitable for all.
- 1.6 The predominantly urban nature of Reading as a town means that an appropriate balance needs to be struck between the needs of local business and the needs of local residents. This licensing policy seeks to encourage all stakeholders to engage in the licensing process so that the needs of all can be taken into account and issues dealt with in a spirit of partnership and cooperation.

Other Initiatives

2.19 Reading's night time economy has achieved Purple Flag and Best Bar None status. These are nationally recognised schemes meaning the town has achieved a level of excellence and we would expect all licence holders and potential applicants to take cognisance of these standards and practices. The Authority and it's partners shall seek to work with all stakeholders in the town to maintain these standards. The town also has a very successful and well attended Pubwatch scheme both in the town centre and in the outer areas of Reading. This scheme is supported by Thames Valley Police and Reading Borough Council and is a particularly useful forum for licence holders to share information, best practice and work in a collaborative manner so as to make the night time economy as vibrant and safe as possible for all. The Authority would expect all prospective applicants and current licence holders to make use of their local Pubwatch scheme and engage fully in any relevant initiatives that stem from it.

Crime and Disorder Act 1998

3.2 This Act requires local authorities and other bodies to consider crime and disorder reduction. Section 17 of the Act states that it shall be the duty of each authority, to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that is reasonably can to prevent, crime and disorder in its area (including anti-social and other behaviour adversely affecting the local environment). This links specifically with the licensing objective of prevention of crime and disorder and the licensing authority will take into account all reasonable measures that actively promote this licensing objective.

Other Legislation that the Licensing Authority will consider

- 3.7 The Licensing Authority will also have cognisance to the following legislation when it decides to discharge it's responsibilities under the Licensing Act. This list is not exhaustive:
- Environmental Protection Act 1990 which deals with noise and nuisance
- Regulatory Reform Order 2005 which deals with fire safety
- Highways Act 1980 which deals with pavement café licences
- Reading Borough Council Act 2013 which deals with street trading and touting
- Health and Safety at Work Act 1974 and Food Hygiene regualtions
- Planning legislation (see paragraphs 2.2-2.9 of this policy)

Licensable Activities

- 4.15 This policy relates to all applications for the following licensable activities:
- The sale of alcohol by retail
- The supply of alcohol to club members
- The provision of regulated entertainment:
- Performance of a play
- Performance of a film

- An indoor sporting event
- Boxing or wrestling
- Performance of live music
- Performance of recorded music
- Performance of dance
- The provision of late night refreshment (the sale of hot food and drink between 2300hrs and 0500hrs)

Review of a premises licence or club premises certificate

- 5.13 Any premises that has a premises licence or club premises certificate may have that licence reviewed by any of the named Responsible authorities including the Licensing Authority in it's role as a Responsible Authority. Thames Valley Police may also submit a Summary Review if there is a premises associated with serious crime and disorder. When the Licensing Authority instigates a review it will ensure that there is a clear separation of functions between the officer acting as the licensing authority and the officer acting as a responsible authority.
- 5.15 The Act provides strict guidelines, timescales and procedures for review applications and hearings and the Authority will deal with every review application in accordance with these rules.

7. Licensing Hours

General Approach

- 7.1 The Licensing Act 2003 gives the licensing authority the power to make decisions about the hours during which premises can conduct licensable activities as part of the implementation of this policy. The licensing authority will make appropriate decisions on licensing hours for the locality of each premises. All applications will be considered on its individual merits.
- 7.2 When an application receives representations, the authority may consider reducing the opening hours and times for licensable activities if it considers it appropriate for the promotion of the licensing objectives.
- 7.4 Where it is deemed appropriate and proportionate to do so, the authority may seek to reduce the hours for licensable activities in order to promote an orderly and gradual dispersal from a certain area or certain premises.

Enforcement Approach

- 9.12 Where offences are found to have been carried out on licensed premises, the Authority has a number of enforcement options available to it. The Authority will work with partner agencies to determine which enforcement option is appropriate for the promotion of the licensing objectives. The seriousness of the offences found will be taken into consideration as well as any previous issues of non-compliance or criminality that have taken place at the licensed premises.
- 9.13 The enforcement options available to the Authority are wide-ranging. The

Authority may consider, for example, that a letter detailing the issues found during an inspection followed by a period of time to rectify them is sufficient to promote the licensing objectives. Similarly, the Authority may consider that the breaches are sufficiently serious to warrant an immediate performance meeting with a licence holder so that a discussion can take place about the adequacy of the processes in place at the premises. This could, for example, lead to recommendations being put to the licence holder to implement much more robust conditions and processes to avoid a repeat of the breaches found. The authority may also decide to prosecute relevant persons for offences being carried out on licensed premises. Licence holders should note that the authority can take one or more of these options available to it at the same time for the same offences should it be deemed appropriate to do so.

- 9.15 Licensed premises that have a history of non-compliance over a period of months and years and/or incidents of serious crime taking place at that premises, will likely find that the Authority will initiate a review with a view to asking for the licence to be considered for revocation.
- 9.16 When considering what enforcement action to take, the Authority will always consider what is the most appropriate and proportionate step to promote the licensing objectives. The Authority is not required to wait for offences to occur before deciding it needs to take appropriate action. Case law notably East Lindsey District Council v Abu Hanif states that the promotion of the licensing objectives requires a prospective consideration of what is warranted in the public interest having regard to the twin considerations of prevention and deterrence. Similarly, the Secretary of State's Guidance to the Licensing Act makes clear that there is no requirement for the Authority to wait for the outcome of any criminal proceedings before it initiates any enforcement action. This is the approach that the Authority will take when considering what, if any, action should be taken when condition breaches and other criminal activity is found at licensed premises.
- 9.18 Any responsible authority or person defined as 'any other person' within the Act can initiate a review of any premises licence or club premises certificate. When another responsible authority or other person initiates a review, the Authority will deal with it as the Licensing Authority and may also wish to make representation in support of the review within it's role as a responsible authority if it has relevant information.
- 9.20 The Authority shall endeavour to work with licence holders and applicants where it is believed that steps can be taken to rectify issues identified at licensed premises. However it cannot merely continue that approach if it has previously failed or the licence holder is unresponsive. It is the responsibility of all licence holders and responsible authorities to ensure that licensed premises are not undermining the promotion of the licensing objectives and that licensable activity is carried out lawfully. The Authority will work with partners to determine what action is appropriate for each premises where issues are discovered. Each premises and the action required for each will be assessed on it's own individual merits.
- 9.21 The Council, in determining a review application can take the following steps

in order to promote the licensing objectives:

- modify the conditions on the licence
- exclude a licensable activity from the scope of the licence
- remove the designated premises supervisor
- suspend the licence for a period not exceeding three months
- revoke the premises licence

This premises is currently associated with serious crime and serious disorder in that on two consecutive occasions within the first week of January 2020 serious incidents impacting the prevention of crime and disorder objective have occurred.

The first incident took place whilst the premises was open for New Years Eve during which at approximately 0205 hours on 01/01/2020 disorder broke out within the first floor bar area where an externally promoted "Urban" event was taking place. This event had been promoted by a company using the name ODM Entertainment via Facebook and tickets sold via a number of online suppliers.

This incident resulted in one male being knocked unconscious in the street having left the premises and also to a number of sporadic fights within the premises and assaults on security staff and also one of my officers.

Initially staff and door supervisors within the club requested assistance to maintain order within the premises and a number of officers had to deploy within the premises to assist in restoring order whilst clearing the venue when the designated premises supervisor advised them he was closing the premises.

Officers report that the crowd was hostile throughout the incident and a Police line had to be used to disperse the crowd from the street utilising over twenty officers and preventing a number of resources from attending other immediate calls for service.

This incident alone had already led to the initiation of evidence gathering for a review of the premises licence, however a further second incident occurred on Saturday 4th January 2020 at approximately 2100 hours.

On this occasion Police received information that a large and angry crowd were gathering outside of Yates, Friar Street due to an externally booked birthday party whereby a number of the attendees were not old enough to enter. Information suggested that the DPS was attempting to decide whether or not to let them in as the crowd was agitated and behaving similarly to those who attended the New Years Eve event.

Initial Police Community Support officers whom attended reported sporadic fighting and withdrew until more units were available to attend.

In essence approximately 150 persons gathered in the street; the majority of whom were all under 18 years of age. When informed they were unable to enter the premises they refused to leave the area and small pockets of disorder ensued across Friar Street.

Due to the number of persons and aggression towards officers they were forced to withdraw and form a Police line across the street to maintain order.

Again a large number of police units were forced to attend Yates to maintain order within the street due to a poorly managed event whereby a failure of due diligence had led to issues of serious crime and disorder.

The degree of disorder observed at this premises has resulted in serious injuries to at least one customer on New Year's Eve, and a number of others which we believe remain unreported due to the uncooperative nature of the crowd on the night.

On the second occasion the disorder and size and nature of the crowd attracted to the town by this booking also led to the requirement of large numbers of police to attend to maintain both order and control of the streets.

Both of these incidents raise very serious concerns over the safety of all members of the public, venue staff and Police Officers and it is clear to me that this premises is clearly and currently undermining the licensing objectives.

This premises has already been subject to Police concern regarding ongoing issues with the suitability of the management and promoted events within the premises and in relation to a failure over a number of years to comply with conditions on their licence.

It is my opinion that Yates have been associated with serious crime and serious disorder and I believe that it is necessary for this licence to be suspended immediately pending the full hearing.

Currently the premises is already under investigation regarding the New Years Eve incident and the DPS is fully aware of this process. We would expect that as part of that process increased standards should have been put into place to ensure such

further incidents did not occur.

However it is of most concern we have instead seen a continuation of disorderly conduct of their patrons that have been attracted to the premises as part of a booking whereby the required due diligence had not taken place.

This decision has been made in order to uphold the licensing objectives and both to prevent crime and disorder, protect children from harm and to ensure public safety.

4. Details of association of the above premises with serious crime, serious disorder or both:

On 1st January 2020 at approximately 0203 hours Police received reports of disorder taking place both outside of Yates, Friar Street, Reading whereby a customer had been knocked unconscious in the street, and also within the premises where staff had lost control of the crowd within the first floor bar.

This incident took place during an externally promoted "Urban" music event which had taken place irrelevant of previous interventions from Thames Valley Police earlier in the year to address concerning external promotions.

Sergeant Cameron who attended at scene describes in a Gen 40 report that officers were informed that 200 persons within the premises were fighting and that they required the help of police to restore order as their staff were unable to deal with the magnitude of the disorder. Sgt Cameron also describes that the crowd were aggressive towards the officers in attendance and that both the management and security staff within the premises were inadequate in both their action and experience.

Body worn Video of PC 1728 provides evidence that she was assaulted by being hit to the head by one of the crowd within the venue and shows the aftermath in the premises where smashed glass is being cleared up and tables and chairs are seen to have been overturned.

Police deployed 20 plus officers to maintain order in the premises and then on Friar Street. As stated earlier one person was reported to have been injured by a bottle and knocked unconscious within Friar Street, and at least two further persons are seen being arrested on police body worn video in Cross Street and also outside of the premises entrance on the premises CCTV.

CCTV of the fight inside the venue on the dancefloor is also available having been requested from the premises (however at the time of completion both supplied copies have been faulty), as well as Police CCTV detailing the street dispersal and volume of police units required to attend.

On 4th January 2020 at approximately 2100 hours multiple police units again had to attend Yates, Friar Street due to reports of disorder outside of the premises involving up to 150 persons linked to an externally booked birthday party!

On arrival police units discovered a large crowd of teenagers between the ages of 16 to 18 years of age stood on the pavement and road outside of the premises in an agitated state. The DPS John Button informed officers that this was due to a birthday booking which had been taken and that a number of under 18 persons had arrived who were not going to be let in.

Button stated that he believed that no money had been taken by the organisers for the booking and that the main issue was going to be dispersal of the crowd.

Unfortunately it transpired that the "family" who booked the premises charged £2 per wristband for entry and this left a large number of disgruntled teenagers outside the premises, with the majority of the male contingent showing aggression towards security staff and police.

In a similar manner to New Years Eve the male element of the crowd became very aggressive leading to police intervention and a line being created across the street to protect other members of the public and further disorder.

Sporadic pockets of disorder did occur but due to officers being considerably outnumbered they were forced to withdraw across the street and in a hope to deescalate the situation.

During the interactions with the children it was stated on the body worn video of PC Wheeler that some of them (only 16 years of age) had already been within the premises prior to police arrival.

And a report was later received from the parent of a 14 year old boy that he son had been located inside the premises with access to alcohol.

Yet again there was a clear element of negligence on behalf of the premises management to both prevent such an incident via due diligence when arranging bookings, and then an inability to deal with it once it had occurred.

Police were initially able to eventually maintain order on the street, however this serious disorder should not have had the opportunity to occur and could have been prevented had the premises licence holder ensured that the correct steps were taken to prevent further incidents after the New Years Eve disorder.

However the crowd that had been attracted to the area for this booking were involved in an attack on a member of the public's car and also caused anti-social behaviour and disorder throughout the whole evening leading to the requirement for a dispersal order to be issued.

To reiterate, multiple resources were used to maintain order on the streets and specialist units such as dog handlers were required to attend to support other uniformed officers. The Police Officers detail being heavily outnumbered and working in a very hostile environment on both occasions.

Officers involved during the first incident anecdotally indicated that the scene inside the venue was chaos, describing that they felt twice as many security staff would not have been able to control the disorder inside.

Attending Officers highlight the following areas of serious concern to them:-

Venue staff failed to disperse the crowd.

Staff were instructed on multiple occasions to disperse the crowd before assisting. Some door staff appeared to be of a poor standard, described as attempting to lock

themselves in the premises rather than helping dispersal on the street.

The DPS and PLH failed on both occasions to demonstrate due diligence in relation to the usage of external promoters and or bookings leading to serious crime, and serious disorder.

For further information Thames Valley Police attempted to address concerns with the premises licence holder in June and July 2019 with specific regard to the usage of external promoters, high risk events and general concerns with regards to due diligence and a failure to adhere to licensing conditions.

This led to a minor variation being applied for by the PLH to add conditions to the licence which it was hoped would address all of our concerns. Sadly this has failed!

Due to the failure of the PLH at this time to promote the licensing objectives and provide sufficient measures to both prevent serious crime and disorder, promote public safety and ensure the protection of children from harm Thames Valley Police respectfully requests that the Licensing Committee takes the interim step of suspending the Premises Licence to prevent further violent incidents, public disorder and the sale of alcohol to children.

I have considered the Home Office guidance regarding Summary reviews, particularly Para 2.4 which asks me and the certifying Senior Officer to address four points.

- Track record of premises Attempts have been made to address issues at the premises earlier in 2019 leading to a minor variation and a number of conditions being further added to the licence. These additions have failed to ensure that the PLH does not continue to undermine the licensing objectives. Furthermore, we would have expected that immediate improvements would have been made after the incident which occurred on NYE after which we were already collating evidence for a review of the premises licence. However, the fact that the premises did not respond to that incident by making immediate improvements and the second incident occurred literally days afterwards demonstrates the track record of the premises is not favourable.
- 2. Nature of Crime and disorder A person has received a serious head injury which left him unconscious outside of the premises during an incident involving persons from the premises. Furthermore a large fight involving multiple persons on the first floor dancefloor and bar area led to police having to enter the premises to maintain order. Also a large crowd dispersal incident occurred on both the 1st and 4th of January 2020 involving numerous pockets of disorder that required Police public order tactics to clear the area and maintain order on the streets. order tactics to clear the area and maintain order on the streets.

- 3. Should alternative powers be deployed, such as a standard review A standard review had already been considered and was already in preparation in relation to the incident on NYE. Of serious concern however is that the premises which ought to have been taking extra care to ensure they prevented further incidents of crime and disorder failed to take such steps leading to the second incident on the 4th January 2020 leaving no alternative but to take this serious action in order to prevent further incidents. We are also aware that an event has already been booked for the 11th January 2020 as a risk assessment has been provided to us by the DPS detailing this as an "Urban" music event. Thames Valley Police suggest that as this event has already been advertised and booked that there are serious concerns that even if it were to be cancelled that inadequate steps would be put into place by the PLH/DPS to ensure that the cancellation is advertised correctly via the promoters. Potentially this could lead to further incidents at the premises which can only be avoided were the premises licence to be suspended whilst measures were put into place to improve the premises performance.
- 4. What added value will an expedited process bring This process and interim steps will conclusively ensure that the licensing objectives are no longer undermined and is the only method available to ensure public safety and the prevention of further serious crime and serious disorder in the interim period between the review hearing.

Thames Valley Police believe that the immediate suspension of the licence shall both prevent further serious disorder but shall also provide a suitable period of time for the PLH to ensure that suitable steps are taken to both investigate and respond to the serious failings at this premises. We strongly feel that this course of action must be taken at this stage to protect the public and in order to promote the four licensing objectives.

However, If you are of a mind not to suspend the licence we suggest that all of the following steps be implemented.

Immediate removal of the DPS.

2. Modify the licence conditions by the inclusion of a licensing condition stating words to the effect "NO EXTERNALLY PROMOTED EVENTS OR BOOKINGS SHALL BE UNDERTAKEN, AND NO EXTERNAL PROMOTERS UTILISED".

Modify the times for both the sale of alcohol and all licensable activities on Monday to Sunday to cease at 2300 hours.

Modify the hours open to the public Monday to Sunday for closure at 2330 hours.

Please note that our concerns with a non suspension of the licence are two fold in that promotions and bookings which have already been taken for potentially high risk events shall likely lead to persons planning on attending the events arriving at the premises and causing further disorder if the premises is found open.

And secondly, the management issues and lack of control at this premises is currently so inherent that we believe the PLH would actually benefit from a period of time to resolve these key concerns and allow for a suitable period of time for all responsible authorities to reflect upon the steps which must be taken to ensure serious disorder is prevented from occurring at this premises again.

National of Incident - what reppered?

SCAS were called initially to YATES bar where there was a report of a person unconscious as a result of an assault. As police also arrived there was a report of a large disorder taking place on the top floor. Officers were asked to go upstairs because door staff couldn't deal with it as there were 200 people fighting.

Officers then went inside and there was a large scale disorder inside. Officers had to call an assistance shout due to the large amount of violent males. Doorstaff were not dealing with this at all. One was even seen coming outside the toilet and just standing looking around for ages. The manager looked out of his depth and wasn't gripping up at all and wasn't directing his staff to deal with what was going on.

Due to officer safety and the ability of doorstaff not getting involved the manager asked if we could assist getting everyone out. Doorstaff and the Manager had to be told to take control and get people out.

As a result over 300 people all came onto the street and were being very aggressive towards police and disorderly in general. The crowds were not dispersing and door staff were not assisting police in getting crowds to disperse. Small pockets of violence were taking place within this crowd also. This was a ticketed event. The crowd was very hostile throughout the entire incident and extremely intoxicated individuals within.

Doorstaff at one point tried to lock the doors and stay inside. The Duty Sgt had to tell the door staff to get outside and deal with the crowd to which they eventually did.

After speaking to other officers we only saw 1 doorman dealing with the crowd. The manager was nowhere to be seen. Officers have now stated that the doorstaff were actually from Walkabout who were assisting police in the lines to remove people from town and they don't remember seeing any from Yates assisting.

At one point PS Palmer heard the manager say something along the lines of "I'm going to lose my job now". The people who were ejected continued to cause issues throughout the town (outside McDonalds later too).

Premises Response - what part did staff play? How did they react/assist? (ladude good/goor performance)

The manager of the bar was not playing an active role in directing his staff to help clear disperse the crowds. As/when the police decided to create a line and help clear the crowds the staff started to assist but this was quite a delayed response (later thought to be Walkabout doorstaff and not YATES).

Doorstaff were seen to try and lock the doors keeping all the staff inside until PS Cameron told them to get out and assist with the mess they had created.

PS Cameron had to tell the management to get his staff to assist with the huge disorder upstairs but they looked and acted like they were way out of their depth.

Police Response - what action was taken? Please identify the main officers who dealt with the incident

The police put themselves at huge risk entering the premises because the doorstaff could not deal with what was going on.

They then had to call for assistance and were threatened and assaulted by people in the venue.

A lot of the clientele were aggressive and actively resisting.,

Police initially gathered and dispersed the large crowd into smaller crowds. As people were not dispersing they then made a line and started to walk people away from the venue and away from town. This was met with a lot of resistance from the crowd and disorderly behaviour and public order. This took over 20 officers to disperse and also took police away from other jobs (3 unresourced immediate). This dispersal took around 30-40 minutes to clear in total







Visit to the premises for the purposes of conducting a licensing investigation into an incident of serious disorder at the premises on New Years Eve involving an externally promoted event.

A number of questions were posed to the DPS John Button and cctv and documentary evidence viewed.

The CCTV was viewed at site that showed a number of sporadic mass disorders occurring within the first floor bar area of the premises – This evidence was deemed as key.

Premises Response - what part did staff play? How did they react/assist? (include good/poor performance)

The DPS stated that the event was a "generic" NYE event and nothing more than that and stated that he had viewed promotional material which supported that, as well as carrying out his own due diligence.

CCTV was provided later in the evening (two discs) from two separate hard drives containing different cameras.

An event booking risk assessment form was provided covering minimal information in relation to the booking.

A report form completed by the DPS was also provided that had been completed on the night and also provided a brief summary of the incident.

A copy of the door book entries for the night was also provided.

The DPS also indicated that there were potentially some events of a similar nature already pre-booked for January, the first occurring on the 11th January 2020.

The CCTV that was viewed from the venue internal camera showed a number of fights occurring in the upstairs bar area which the security team and management were seen to be unable to manage. The footage also showed multiple Police officers entering the premises to maintain order.

External cameras capture officers having to form lines to clear the streets and at least one person being arrested outside of the premises – (Currently the requested footage from the external and downstairs cameras has been produced and playable. The cameras covering the first floor where the incident took place have yet to be successfully provided as both copies of disc provided to us have not worked)!

The risk assessment appears wholly inappropriate for the event and does not truly reflect that nature of the event ie an externally promoted "Urban" music event. This is also reflected in the statements of the DPS suggesting that it was not such an event. Open source social media searches however have concluded that the event was clearly promoted by ODM Entertainment as an Urban music event and as such this raises concerns that the DPS has either deliberately made false representations to us or that he has failed in his due diligence to check the promotional material.

• Of further concern is that the NYE event booking RA details the event finishing time as 0230 hours, however the event was advertised as finishing at 0400!

This booking form was provided to Thames Valley Police and provided a false declaration in relation to the end time of the event which also would have had further implications for the levels of risk.

I also note that the description of the incident within the premises report that the DPS prepared does not truly reflect the severity of the incident.

Consecutively the notation within the door book also fails to provide suitable detail in relation to a large scale disorder which in effect led to the premises being prematurely closed on the night.

*Recommend that due to previous unsuccessful interventions with the Premises Licence Holders in June and July 2019 to rectify concerns over the prevention of crime and disorder and public safety surrounding externally promoted events and failures of due diligence that a review of the premises licence is required to be completed.

Nature of Incident - what happened?

Police were called to Yates having received information that large numbers (eventually estimated at 150) were gathered outside of the premises and acting in a disorderly aggressive manner.

The circumstances were that an external booking for a birthday party had been taken where it transpires that the organisers (a family?) charged persons £2 to purchase a wristband for entry.

However the majority of the attendees were under the age of 18 and in fact aged 16 and 17 years old.

They were at this stage now being denied entry due to their ages and were angry that they were unable to enter the premises. The venue was unable to manage the situation and were severely understaffed to manage this scenario.

Facts that presented themselves were that a number of the children stated that they had already been inside the premises and the management appeared to have no management or control of the booking.

During attempted dispersal officers were surrounded by crowds of aggressive individuals causing officer safety issues.

Having had to provide a large number of officers to maintain order in the street, pockets of disorder took place throughout the evening involving the group. This led to a persons vehicle being attacked, and a report from a parent of a child who was 14 years old that they had been located inside the premises with a number of other under aged children whom had access to alcohol.

Finally a section 34 authorisation had to be put into place to deal with disorderly groups that remained within the town centre and that had been linked to this event.

Premises Response - what part did staff play? How did they react/assist? (include good/goor performance)

The DPS initially stated that the event was a Birthday party and that he had no idea that the attendees would be under 18 years of age. He also stated that no person had purchased tickets for this and that only a deposit for the premises had been paid by the family who booked the event.

Mr Button also said that ID scanner was being used and no one under 18 years of age could enter the premises.

The premises response in effect was extremely poor, and it appeared that no due diligence had been undertaken in relation to the booking and there was a lack of security available to deal with the scenario that developed.

The incident had the potential to have caused the same type of issues as seen on NYE and in effect caused sporadic incidents of disorder throughout the entire evening within Reading town centre.



LICENCED PREMISES INCIDENT REPORT

Door staff appeared scared or unable to ask the individuals to leave (however when looking at the behaviour of a large number of individuals within the crowd this was to a degree understandable).

Police Response - what action was taken? Please identify the main officers who dealt with the incident

Multiple Police were required to attend to manage the situation at Yates and had to remain in the area initially for at least one hour.

A Police line was eventually formed in the road opposite the premises to prevent the pockets of disorder spreading and the impact of the crowd's actions from effecting other members of the public.

Unfortunately as had occurred on NYE this event again had attracted individuals to the town that wished to crowd on mass and cause disorder and act aggressively and confront police and other figures of authority such as security staff.

This led to a member of public's car being attacked and groups acting in an anti-social manner remaining in the town for a number of hours.

Police responded by issuing a Section 34 dispersal notice in an attempt to maintain order on the streets.

*Recommend immediate summary review of the premises licence in order to support the licensing objectives in order to prevent crime and disorder and ensure public safety.

The current Premises Licence Holders and DPS have failed on two occasions over a four day period to promote the licensing objectives and on both occasions this has led to serious disorder.

It would be expected that after the NYE incident that measures would have been put into place to ensure that external events/ bookings were undertaken in a manner that does not undermine the licensing objectives, however evidence is such that immediate action must be taken to prevent further incidents of this nature.

The information provided will be cross-referenced with our own Police systems and data sources to assist with the risk assessment process.

The information is processed in accordance with our policing purpose as defined by the Code of Practice for the Management of Police Information (MoPI) as follows:

- Protecting life and property;
- Preserving order;
- Preventing the commission of offences;
- Bringing offenders to Justice;
- Any duty or responsibility arising from common or statute law



ANNEX B

Application for the review of a premises licence under section 53A of the Licensing Act 2003 (premises associated with serious crime or disorder)

1. INTRODUCTION

- 1.1 This guidance explains how to use the provisions in the Licensing Act 2003 ("the 2003 Act"), inserted by section 21 of the Violent Crime Reduction Act 2006, which allow a quick process for attaching interim conditions to a licence and a fast track licence review when the police consider that the premises concerned is associated with serious crime or serious disorder (or both).
- 1.2 This guidance has no statutory basis but is intended to assist police forces and licensing authorities when considering using the procedures.
- 1.3 The powers are set out in sections 53A to 53C of the 2003 Act and apply only where a premises licence authorises the sale of alcohol. They do not apply in respect of other premises licences, or to premises operating under a club premises certificate. The purpose of these powers is to complement existing procedures in the 2003 Act for tackling crime and disorder associated with licensed premises. Existing powers in the Anti-social Behaviour, Crime and Policing Act 2014 provide for the instant closure of premises by the police in some circumstances (in essence, disorder or nuisance) and the consequent review of premises licences by the licensing authority. The powers under sections 53A to 53C of the 2003 Act, are aimed at tackling serious crime and serious disorder, in particular (but not exclusively) the use of guns and knives.

1.4 The powers allow:

- the police to trigger a fast track process to review a premises licence where the police consider that the premises are associated with serious crime or serious disorder (or both); and
- the licensing authority to respond by taking interim steps quickly, where it considers this is necessary, pending a full review.

1.5 In summary, the process is:

- the chief officer of police for the area in which the premises are situated may apply to the licensing authority for an expedited review of a premises licence where a senior police officer has issued a certificate stating that in his/her opinion the premises are associated with serious crime or serious disorder (or both);
- on receipt of the application and the certificate, the licensing authority must within 48 hours of the time of its receipt consider whether it is necessary to take interim steps pending determination of the review of the premises licence the authority must in any event undertake a review within 28 days after the day of receipt of the application.
- 1.6 The options open to the licensing authority at the interim steps stage include:
 - modification of the conditions of the premises licence;
 - the exclusion of the sale of alcohol by retail from the scope of the licence;
 - removal of the designated premises supervisor from the licence; and
 - suspension of the licence.

- 1.7 Following the full licence review, the licensing authority may do any of the above or may revoke the licence.
 - 1.8 The purpose of this guidance is to:
 - set out the circumstances where the power can be used; and
 - outline the process and the steps at each stage.

2. THE STEPS

Triggering the expedited review

2.1 Section 53A of the Licensing Act 2003 sets out who may apply for an expedited review and the circumstances in which it can be used.

Application for expedited review

- 2.2 The chief officer of police for the area in which the premises are situated may apply to the relevant licensing authority for an expedited licence review if a **senior member** of the force has issued a **certificate** that in his/her opinion a licensed premises is associated with **serious crime or serious disorder (or both).**
 - 2.3 The key definitions used above are:
 - Senior member of the force: This must be an officer of the rank of superintendent or above.
 - Certificate: This is a formal note which identifies the licensed premises and includes a signed statement by a senior officer that he believes the premises is associated with serious crime, serious disorder or both. This form is not prescribed in legislation. However, a sample form which forces may wish to adopt is attached at annex A to this guidance.
 - Serious crime: The tests to determine the kinds of conduct that amount to serious crime are set out in section 81(2) and (3) (a) and (b) of the Regulation of Investigatory Powers Act 2000. Those tests are that the conduct:
 - (a) constitutes an offence for which a person who is 21 years of age or over with no previous convictions could reasonably be expected to be sentenced to imprisonment for 3 years or more; or
 - (b) Involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.
 - Serious disorder: There is no definitive list of behaviours that constitute serious disorder, and the matter is one for judgment by the local police. The phrase should be given its plain, ordinary meaning, as is the case under section 12 of the Public Order Act 1986 in which it is also used.
 - The application for a summary or expedited review: this is an application made by, or on behalf of, the Chief Officer of Police under section 53A of the 2003 Act. The application must be made in the form which is set out in Schedule 8A to the

Licensing Act 2003 (Premises licences and club premises certificates) Regulations 2005 (SI 2005/42). The completed application must be accompanied by the certificate issued by a senior officer. The form which must be used is reproduced in annex B of this guidance.

- 2.4 In deciding whether to sign a certificate, the senior officer will want to consider the following (as applicable):
 - The track record of the licensed premises concerned and whether the police have previously had cause to give advice about serious criminal or disorderly conduct (or the likelihood of such conduct) attributable to activities taking place on the premises it is not expected that this power will be used as a first response to a problem.
 - The nature of the likely crime and/or disorder is the potential incident sufficiently serious to warrant using this power?
 - Should an alternative power be deployed? Is the incident sufficiently serious to warrant use of the powers in Part 4, Chapter 3 of the Anti-social Behaviour, Crime and Policing Act 2014 to close the premises? Or could the police trigger a standard licence review to address the problem? Alternatively, could expedited reviews be used in conjunction with other powers (for example, modifying licence conditions following the use of a closure power).
 - What added value will use of the expedited process bring? How would any interim steps that the licensing authority might take effectively address the problem?
- 2.5 It is recommended that these points are addressed in the chief officer's application to the licensing authority. In particular, it is important to explain why other powers or actions are not considered to be appropriate. It is up to the police to decide whether to include this information in the certificate or in section 4 of the application for summary review. The police will also have an opportunity later to make representations in relation to the full review.
- 2.6 In triggering the process, the police will wish to take into account the fact that an intended use of the power is to tackle the use of dangerous weapons and the violence they fuel. For example, in appropriate circumstances the police might want to make representations to the licensing authority suggesting that they modify the conditions of the premises licence to require searches of customers for offensive weapons upon entry. Under the powers in sections 53A to 53C, this could be done on an interim basis pending a full hearing of the issues within the prescribed 28-day timeframe.
- 2.7 Similarly, the power could, where appropriate, be used to reduce the risk of injury caused by glass by requiring the adoption of a safer alternative (but see paragraphs 3.6 and 3.7 below).
- 2.8 However, it should continue to be borne in mind that these are selective measures. It is not the aim to require all licensed premises to undertake these searches or use toughened glass. Rather, the policy aim is to provide a selective tool, to be used proportionately, to limit this condition to those pubs that are at risk either because police intelligence shows there is a risk of knives/guns being carried or because crime and disorder has occurred on the premises.

3. The Licensing Authority and the interim steps

- 3.1 Within 48 hours of receipt of the chief officer's application, the licensing authority must give the premises licence holder and responsible authorities a copy of the application for review and a copy of the certificate, and must also consider whether it is necessary to take interim steps. When calculating the 48 hour period any non-working day can be disregarded¹.
- 3.2 The licensing authority may want to consult the police about the steps that it thinks are appropriate, pending the determination of the review, to address the immediate problems with the premises, in particular the likelihood of serious crime and/or serious disorder. The licensing authority may consider the interim steps without the holder of the premises licence having been given an opportunity to make representations. This does not, of course, mean that the licensing authority cannot afford such an opportunity if it thinks it appropriate and feasible to do so in all the circumstances.
- 3.3 The determination of interim steps is not a matter that may be delegated to an officer of the licensing authority. The relevant decisions are likely to be taken by a licensing sub-committee. It should also be noted that there is no requirement for a formal hearing in order to take interim steps. This means that the relevant sub committee members can communicate by telephone or other remote means in order to reach a decision. A written record should always be produced as soon as possible after a decision is reached.
 - 3.4 The interim steps that the licensing authority must consider taking are:
 - the modification of the conditions of the premises licence;
 - the exclusion of the sale of alcohol by retail from the scope of the licence;
 - the removal of the designated premises supervisor from the licence; and
 - the suspension of the licence.

Modification of the conditions of the premises licence can include the alteration or modification of existing conditions or addition of any new conditions, including those that restrict the times at which licensable activities authorised by the licence can take place.

- 3.5 If the licensing authority decides to take steps at the interim stage:
 - the decision takes effect immediately, or as soon after it as the licensing authority directs;
 but
 - the licensing authority must give immediate notice of its decision and its reasons for doing so to the holder of the premises licence and the chief officer of police who made the application. The 2003 Act does not specify that the immediate notice has to be in writing. However, in an individual case the licensing authority may consider that the need for immediate communication at least initially requires a non-written approach, such as a telephone call. This may happen when, for example, the authority decides that the decision should have immediate effect. In such a case, the decision and the reasons for it should be explained clearly and in full to the licence-holder (or someone who may

¹ This means that, for example, if the application was received at 3pm on a Friday, the 48 hour period would cover the remaining 9 hours on that Friday and the remaining 39 hours starting on the Monday morning (provided it was not a bank holiday). In this case the licensing authority would have to decide on interim steps by 3pm on the Tuesday.

properly act for the licence-holder), and the call followed up as soon as possible with a written version of the decision and the reasons (for example, by email or fax) which is identical to, or not significantly different from, the version given by telephone.

- 3.6 The licensing authority, in deciding when its decision on interim steps should take effect, should consider the practical implications of compliance in relation to the premises. For example to comply with a modification of the conditions of a licence that requires employment of door supervisors, those running the premises may need some time to recruit appropriately qualified and accredited staff.
- 3.7 In addition, very careful consideration needs to be given to interim steps which would require significant cost or permanent or semi-permanent adjustments to premises which would be difficult to remove if the outcome of the subsequent full review was to withdraw or modify those steps. For example, making structural changes, installing additional CCTV or replacing all glassware with safer alternatives may be valid steps, but might be disproportionate if they are not likely to be deemed necessary following the full review (or any subsequent appeal). The focus for interim steps should be on the immediate measures that are necessary to prevent serious crime or serious disorder occurring. In some circumstances, it might be better to seek suspension of the licence pending the full review, rather than imposing a range of costly conditions or permanent adjustments.

4. Making representations against the interim steps

- 4.1 The premises licence holder may make representations against the interim steps taken by the licensing authority. There is no time limit for the premises licence holder to make representations on the interim steps, although in practice this would at some point be superseded by the full review which would have to be completed within 28 days of the application being received by the licensing authority. On receipt of such representations, the licensing authority must (if the representations are not withdrawn) hold a hearing within 48 hours of their receipt. When calculating the 48 hour period, any non-working day can be disregarded.
- 4.2 The licensing authority must give advance notice of the hearing to the premises licence holder and the chief officer of police. Given that these measures are designed to deal with serious crime and serious disorder on an interim basis only, the process is designed to avoid delay and, as such, significant portions of the Licensing Act 2003 (Hearings) Regulations 2005 (SI 2005/44) (which set out the usual processes governing the conduct of licensing authority hearings) do not apply in order to streamline the hearing process. One result of this is that licensing authority cannot adjourn the hearing to a later date if the licence holder fails to attend at the scheduled time, as is the case under the normal review procedure. And as is the case with that procedure, the licence holder does not have to be present for the hearing to take place. In addition, there is no timescale for notifying the licence holder of the hearing under the modified process, providing the notification takes place before the hearing is held. However, it is imperative that the licence holder be given as much notice as is possible in the circumstances to afford the holder a maximum practicable opportunity to prepare for and attend the hearing. Licensing authorities should bear in mind that the usual principles of public law decision-making will apply to interim determinations, in a form that has regard to the statutory context of an expedited process.

4.3 At the hearing the licensing authority must:

• consider whether the interim steps are appropriate for the promotion of the licensing objectives; and

- determine whether to withdraw or modify the steps taken.
- 4.4 When considering the case the licensing authority must take into account:
 - the senior officer's certificate that accompanied the application;
 - the chief officer's representations (if any); and
 - any representations made by the premises licence holder.
- 4.5 There is no right of appeal to a magistrates' court against the licensing authority's decision at this stage.

The review of the premises licence

- 5.1 The licensing authority must hold a review of the premises licence within 28 days after the day of receipt of the chief officer's application. This must take place even if the chief officer asks to withdraw his application or representations. At the hearing, the licensing authority must:
 - consider what steps it considers appropriate for the promotion of the licensing objectives;
 and
 - decide which interim steps (if there are any) cease to have effect altogether or become the subject of any steps which it considers are appropriate when making its determination on the review.
 - 5.2 The steps the licensing authority can take are:
 - the modification of the conditions of the premises licence;
 - the exclusion of a licensable activity from the scope of the licence;
 - the removal of the designated premises supervisor from the licence;
 - the suspension of the licence for a period not exceeding 3 months; and
 - the revocation of the licence.

Modification of the conditions of the premises licence can include the alteration or modification of existing conditions or addition of any new conditions, including those that restrict the times at which licensable activities authorised by the licence can take place. Further examples of possible licensing conditions, including those aimed at tackling crime and disorder, can be found in the amended guidance under section 182 of the 2003 Act.

- 5.3 The licensing authority must:
 - advertise the review inviting representations from any persons for no less than seven consecutive days, by notice as described in regulation 38 of the Licensing Act 2003 (Premises licences and club premises certificates) Regulations 2005 (SI 2005/42) and, if applicable, on the licensing authority's website (see regulation 38(1)(b) of the above). The relevant notices should be published on the day after the day of receipt of the chief officer's application.

- advertise that any representations made by the premises licence holder, responsible authority and any other persons should be submitted to the licensing authority within 10working days of the advertisement of the review appearing.
- give formal notice of the hearing no later than five working days before the day or first day on which the hearing is to be held to the premises licence holder and to every responsible authority².
- 5.4 A party shall give to the authority a notice no later than two working days before the day or the first day on which the hearing is to be held stating
 - whether he intends to attend or be represented at the hearing;
 - whether he considers a hearing to be unnecessary.
 - whether he would like permission for any other person (other than the person he intends to represent him at the hearing) to appear at the hearing and, if so, explain on which points that person will be able to contribute.
- 5.5 The regulations relating to hearings are set out in the Licensing Act 2003 (Hearings) Regulations 2005 (S.I. 2005/44). They apply to final hearings under the section 53A(2)(b) in a similar way to hearings following closure orders under section 167 of the 2003 Act (it should be emphasised that the truncated version of the hearings regulations described in paragraph 4.2 above applies to interim hearings only). The issues they address include who can make representations and what those representations can be about. It is therefore possible for responsible authorities or any other persons to make representations in relation to any of the licensing objectives, not just crime and disorder. Similarly, where it is in the public interest, the regulations relating to the exclusion of individuals from hearings, or conducting the hearing in private, will apply.
- 5.6 The licensing authority must take into account any relevant representations made. Relevant representations are those that:
 - relate to one or more of the licensing objectives;
 - have not been withdrawn; and
 - are made by the premises licence holder, a responsible authority or any other person (who is not also a responsible authority).
 - 5.7 The licensing authority must notify its decision and the reasons for making it to:
 - the holder of the premises licence;
 - any person who made relevant representations; and
 - the chief officer of police who made the original application.

² Responsible authorities are defined under sections 13(4) and 69(4) of the 2003 Act. Page 106

6. Right of

Appeal

6.1 An appeal may be made to the magistrates' court within 21 days of the licence holder being notified of the licensing authority's determination on the review. An appeal may be made by the premises licence holder, the chief officer of police and/or any other person who made relevant representations.

The decision of the licensing authority, following the review hearing, will not have effect until the end of the period allowed for appeal, or

Annex 1

Mandatory Conditions

Supply of Alcohol

To be applied where a premises licence authorises the supply of alcohol

- 1 No supply of alcohol may be made under the premises licence:
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- Every supply of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

Film Exhibitions

To be applied only where a premises licence or club premises certificate authorises the exhibitions of films

- The admission of children to any exhibition of any film must be restricted in accordance with section 20 of Part 3 of the Licensing Act 2003.
- In the case of films which have been classified by the British Board of Film Classification admission of children to films must be restricted in accordance with that classification.
- In the case of films which have not been classified by the British Board of Film Classification, admission of children must be restricted in accordance with any recommendation made by the Licensing Authority.

Door Supervisors

To be applied where a premises licence or club premises certificate includes a condition that any person must be at the premises to carry out a security activity. [Except premises with a premises licence authorising only plays or films or premises used exclusively by a club].

Each individual present at the licensed premises to carry out a security activity must be licensed by the Security Industry Authority.

Responsible Drink Promotions (commencement date 01/10/2014)

- 1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Supply of Tap Water (commencement date 01/10/2014)

1. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy (commencement 01/10/2014)

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Drink Measurements (commencement date 01/10/2014)

- 1. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

Minimum Permitted Pricing (commencement 28th May 2014)

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1-
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—P = D + (DxV)

where-

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that subparagraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- 4. (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2

Conditions Consistent with the Operating Schedule

Conditions added via Minor Variation - July 2019

1. a) A minimum of four door supervisors to be employed at the premises on Friday and Saturday evenings from 20:00 hours until close. On Thursdays, when live music or DJ led entertainment is provided, there will be a minimum of two door supervisors employed at the premises from 20:00 hours to close for the first 150 guests and then 1 additional door supervisor shall be employed for every 75 people thereafter.

At all other times, the need for door staff will be risk assessed and cognisance will be taken of police advice.

- b) A minimum of two door supervisors will be employed Sunday to Wednesday if the premises is to open past 00:00 hours. The premises will employ a minimum of 2 door supervisors the first 150 guests and then 1 additional door supervisor shall be employed for every 75 people thereafter.
- 2. A risk assessment or EMP (Event Management Plan) shall be undertaken to determine a suitable number of door supervisors on any externally promoted ticketed events (excluding events organised through the Premises Licence Holders third party approved contractor). The EMP shall be submitted to Thames Valley Police and Reading Borough Council a minimum of 10 working days before the event is run.
 - (B) All events using promoters, not normally associated with the premise, shall require notification to the Police a minimum of ten (10) working days prior to the event taking place. The notification shall identify the promoter, the event being promoted and the nature of the music being promoted.
 - (C)These events shall be subject to a full risk assessment, to be carried out by DPS, or a nominated individual and be made available on request to an authorised officer of TVP.
 - (D) The risk assessment shall identify when tickets are sold in advance and/or to be available on the night. The risk assessment shall include the requirement for additional measures when searching for illegal drugs and weapons, additional door supervisors including female door supervisors, venue staff, briefing details to all staff, reference checks on all promoters and DJs and where appropriate and the use of a search wands.
- 3. A register of Door Staff shall be kept. The register will show the following details:
 - (a) Full SIA registration number.
 - (b) Date and time that the Door Supervisor commenced duty, countersigned by the Designated Premises Supervisor or Duty Manager.
 - (c) Date and time that the Door Supervisor finished work, countersigned by the Designated Premises Supervisor or Duty Manager.
 - (d) Any occurrence or incident of interest involving crime and disorder or public safety must be recorded giving names of the Door Supervisor involved.
 - (e) A record of the number of patrons on site shall be made half hourly in the

door register

- (f) Training records
- (g) ID Photo and scan of SIA badge
- (f) A record will be kept on site of all SIA checks, on the validity of all door staff licences.
- (g) The name, home address and registration number of all door supervisors working at the premises;
- 4. The door supervisor register must be kept at the premises and be available for inspection by Thames Valley Police or an authorised officer from Reading Borough Council and shall be retained for a period of 1 Year.
- 5. The Designated Premises Supervisor (DPS) and Premises Licence Holder (PLH) shall ensure that a policy relating to the safe removal of persons from the premises and/or its immediate vicinity by staff and door supervisors shall be put in place and actively operated. The policy shall be in written format and made available upon request to an authorised officer of the local Council and Thames Valley Police. This shall include but not be limited to:
 - a) Persons who have been identified by staff as being vulnerable or at risk.
 - b) Persons who are refused entry to the premises or refused service within the premises.
 - c) Persons who are ejected from the premises.
- 6. Whilst Door Supervisors are employed at the premises a minimum of 1 Door Supervisor working on the entrance/ exit to the premises, and 1 internally within the premises (rising to 2 when both floors are in operation) will be deployed with digitally recording Body Worn Video (BWV). The BWV will be used to record any incidents which occur inside or outside of the premises involving customers, prospective customers or any staff member that impact on any of the four licensing objectives. Data recordings shall be made immediately available to an authorised officer of Thames Valley Police or an officer from the Reading Borough Council together with facilities for viewing upon request, subject to the provisions of the Data Protection Act.
- 7. The Premises Licence Holder (PLH) shall ensure that all door supervisors whilst employed at the premises shall wear hi visibility jackets/ tabards in bright green, yellow or orange in order that they can be clearly visible and identifiable at all times to the public and via CCTV both internally and externally. When tabards are worn, hi visibility armbands must also be worn that incorporate displaying SIA badges. If hi visibility full sleeved jackets are worn the PLH must ensure that all door supervisors badges are also displayed via an easily visible arm band of a different hi visibility colour to the jacket that is being worn.
- 8. All door personnel employed at the premises will be trained in respect of the Door Staff Operational Plan and a signed training record to confirm the same will be maintained for production to the Police upon request.
- 9. All incidents which impact on any of the four licensing objectives shall be recorded in a register kept at the premises for this purpose.
 - (a) The name of the person recording the incident and those members of staff who deal with any incidents shall also be recorded. Where known, any offender's name shall also be recorded.
 - (b) The incident book shall truly reflect what has occurred and shall be specific in detail. If incidents involve members of staff, including Door Staff, their names

shall be entered onto the log book. All incidents shall be signed off either by the Designated Premises Supervisor (DPS) or the nominated individual when the DPS is not on site.

- 10. The Premises Licence Holder shall use reasonable endeavours to ensure that when two or more door supervisors are on duty, at least one female door supervisor shall be employed and available where appropriate (for example, if a female customer is subject to a body search).
- 11. A policy covering searching of patrons and staff members must be submitted to and approved by Thames Valley Police. The approved policy must be <u>actively</u> operated within the licensed premises;

The Premises Licence Holder shall implement a written search policy to minimise the risk of illegal weapons and drugs being brought onto the premises, including search, detection, confiscation, storage and disposal of drugs procedures. The search policy shall provide, as a minimum:

- (a) For 100% bag search of all customers attempting to enter the premises, from 21:00.
- (b) For searches of any customer when considered appropriate by PLH's Security personnel or PLH Management based on risk assessment of the night in question; Minimum 50%
- (c) For the operation of intelligence lead searches of any customer as required.
- 12. Notices shall be displayed advising the public that the right to conduct an outer body search is reserved as a condition of entry, and that the TVP shall be informed if anyone is found in possession of illegal drugs or offensive weapons;
- 13. Only toughened drinking vessels (excluding bottles) shall be used on the premises with the exception of where they are not produced/available for purchase by the operator. This does not include wine or champagne glasses or other such glassware as agreed in writing with the Police Licensing Officer.
- 14. The Premises Licence Holder must ensure that the Designated Premises Supervisor holds membership of, and actively participates in, the Reading Pub Watch Scheme, including making use of apparatus supplied as part of the scheme;
- 15. The Premises Licence Holder shall ensure the premises' digitally recorded CCTV system cameras shall continually record whilst the premises are open to the public and recordings shall be kept for a minimum of 31 days with time and date stamping. The entire licensable area shall be covered by the CCTV. Recorded images shall be of such quality as to be able to identify the recorded person in any light. Data recordings shall be made immediately available to an authorised officer of Thames Valley Police or Reading Borough Council together with facilities for viewing upon request, subject to the provisions of the Data Protection Act. At least one member of staff on the premises at any time during operating hours shall be fully trained to access and download material from the CCTV system.
- 16. A sign advising customers that CCTV is in use shall be positioned in a prominent position.

Dispersal

- 17. A written entry, closure and dispersal policy for controlling the opening, closing of the premises and the departure of customers at the conclusion of the licensed activities shall be put in place and shall be actively operated. This policy shall be made available to any authorised Officer of Thames Valley Police or an authorised Officer of Reading Borough council;
- 18. Whilst dealing with the dispersal of patrons the door staff shall wear full high visibility vests.
- 19. There will be no admission or re-admission to the premises after 0100 hours the following morning;
- 20. The licensee shall take all reasonable precautions and exercise all due diligence to ensure that no patron removes glasses or open bottles from the premises, save for any external area provided. The licensee shall display notices advising that glasses and bottles must not be removed from the premises at all appropriate exit points;
- 21. The Premises Licence Holder shall ensure that no noise shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to undue disturbance to local residents;
- 22. All external windows and doors must be kept closed, other than for access or egress, when events involving amplified music or speech are taking place;
- 23. Clearly legible and suitable notices shall be displayed at all exits requesting customers to respect the needs of local residents and to leave the premises and area quietly;
- 24. No music or speech shall be relayed via external speakers other than for events with the prior approval of the licensing authority;
- 25. During operating hours the licensee or nominated representative shall be available to receive and respond to nuisance related complaints a contact number shall be readily available to residents upon request.

Challenge 25 and Club Scan

- 26. At all times that the premises is operating under this licence, the Premises Licence Holder shall ensure that its staff operate a Challenge 25 Policy (to minimise the risk of alcohol being sold to underage customers). This Policy shall (as a minimum provide) that before entry (or alternatively before any sale of alcohol), any person who appears to be under the age of 25 will be required to produce photo ID in the form of a passport; driving licence, UK Military ID card; PASS (or similar) card to prove that he/she is over the age of 18, before being permitted;
- 27. Notices advertising the Challenge 25 and proof of age policies shall be displayed in prominent places in the premises so that they can be seen internally and externally;

ID Checks

- 28. An ID scanning system will be installed and maintained at the premises. The ID scanner will be in use as follows:-
- a) From 21.00 on Fridays and Saturdays all persons shall be subject to the ID scanner (save for the exemption in 28d below)
- b) When door staff are on duty any person who would be subject to the Challenge 25 policy shall be scanned. Patrons not subject to Challenge 25 will be subject to risk assessment to determine whether they should be scanned.
- c) At all times on days when the premises have assessed that there is a high risk event, major sporting event or promoter led events taking place (save for the exemption in 28d below)
- d) As an exception to this if the DPS or nominated deputy express any discretion to any person not going through the identification machine, then a written record of this must be retained for a period of 31 days. The written record shall include the name of the DPS/ nominated deputy exercising the discretion, a description of the person and the reason why the identification machine has not been used. The record shall be mane available for inspection to any responsible authorities when requested.
- 29. The ID Scan Device shall record the names and dates of birth of all persons entering the premises and retain the image and details of the ID. These records shall be kept for a minimum of thirty one days and shall be made available to any authorised Officer of TVP;
- 30. Records shall be made available to an authorised officer of TVP or an authorised officer of the council together with facilities for viewing with immediate access by a person qualified to operate the system;
- 31. Any breakdown or system failure will be notified to TVP immediately and remedied as soon as practicable;

Staff Training

- 32. Staff employed shall undergo training in relation to the Licensing Act 2003 regarding late night refreshment upon induction. This shall include, but not be limited to understanding the four licensing objectives. Such training sessions are to be documented and refreshed every six months. All training sessions are to be documented in English. Records of training shall be kept for a minimum of one year and be made available to an authorised Officer of Reading Borough Council or Thames Valley Police upon request.
 - I. The Prevention of Crime and Disorder.
 - II. Public Safety.
 - III. Public Nuisance.
 - IV. The Protection of Children from Harm.;
- 33. All staff shall be refresher trained on the law relating to underage sales every three months, on how to question and refuse sales if necessary, utilising the

Challenge 25 policy. Records of the training and reminders given shall be retained.

Beer Garden Area

- 34. The upper balcony shall be closed from 0100 hours until 0800 hours;
- 35. The garden shall be used as the smoking area;
- 36. No alcohol shall be consumed in the garden between 0130 hours and 0800 hours.

Town-safe Radio

37. The Premises Licence Holder shall participate in the Local Town Radio Scheme when the premises are opened for licensable activities after 2100hrs Monday to Sunday inclusive;

Drugs Initiative

- 38. The Premises Licence Holder shall implement an active policy to prevent illegal weapons and drugs being brought onto the premises, including search, detection, confiscation, storage and disposal of drugs procedures;
- 39. The venue shall also actively partake in drugs initiatives run by TVP (including, but not exclusively, drug itemiser, passive drug dogs and spiked drinks campaigns);
- 40. The premises licence holder shall ensure that advertising or promotional material for licensable activities at the premises is not placed on any street furniture, structure or public highway not belonging to the premises licence holder. Failure by the premises licence holder to remove any promotional material illegally displayed will be a breach of this condition and any other legislation that applies in Reading in relation to unlawful advertising on street furniture.
- 41. A written risk assessment shall be put in place to manage the queuing of patrons outside of the venue on the public highway. This risk assessment shall be reviewed on a regular basis, be provided in written form and be made available for inspection to officers of Reading Borough Council and Thames Valley Police upon request.

Content of Application:

On 06 January 2020, PC Simon Wheeler on behalf of the Chief Constable of the Thames Valley Police submitted an application for a summary review (under Section 53a) of the premises licence for Yates, 7-9 Friar Street, Reading RG1 1DB because of their failure to uphold the licensing objectives, namely the Prevention of Crime and Disorder, Public Safety and the Protection of Children from Harm.

The Police attended two incidents of serious disorder at the premises on 01.01.2020 and 04.01.2020.

Licensing Officer's Comments:

The Licensing Authority is making this representation in support of Thames Valley Police in relation to the review Yates, 7-9 Friar Street, Reading RG1 1DB. The Premises is located within Reading Borough Council's Cumulative impact area. The current Premises Licence holder is Stonegate Pub Company Limited.

The Licensing Authority believe that this review is necessary given the two incidents of serious disorder highlighted in the review application and would invite the Licensing Committee to take the steps it deems appropriate and proportionate to promote the licensing objectives.

Reading Borough Council's Licensing Policy statement clearly states that its Vision is "To promote Reading as a safe and healthy environment in which responsible operators provide lawful and responsible facilities for the enjoyment of the Town's residents and visitors".

The statement of Licensing Policy is underpinned by four core objectives:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

The Licensing team in partnership with Thames Valley Police visit and inspect licensed premises within Reading. Particular attention is paid to premises where there have been previous incidents where the Licensing Objectives have not been supported.

The current Premises licence (Licence number LMV000356 dated 11.07.2019) permits the premises to supply alcohol and carry out other licensable activities shown above.

On 24.01.2019, Reading Borough Council Licensing officer attended the premises to carry out a licensing inspection. The officer discussed matters with Mr John Button, the designated premises supervisor(dps). A copy of the licensing letter and replies from the premises are shown at Appendix LIC-1.

Breaches noted by Licensing Officer on 24.01.2019

- 1. A current Part A could not be produced.
- 2. Part B of the premises licence was not being displayed.
- 3. Gaming machine permit could not be produced.
- 4. No risk assessments for special events could be produced.
- 5. No drugs policy could be produced.
- 6. No search policy could be produced.
- 7. No dispersal policy could be produced.
- 8. No customer signage in regards to not removing open containers, glassware and bottles.
- 9. No customer signage in regard to requesting customers to leave quietly.
- 10. Reminder in regard to the hours of operation of the smoking areas.

The Premises licence holders have a duty to be responsible, operate lawfully, adhere to the conditions on their licence and to take every step to promote the licensing objectives at all times, not just to seek to apply them once the responsible Authorities carry out inspections.

26.06.2019 Application submitted for a minor variation to amend conditions following agreement with Thames Valley Police. (Licence LMV000356 issued 11.07.2019)

Revised Guidance issued under Section 182 of the Licensing Act 2003

Application for summary review

12.3 Section 53A of the 2003 Act sets out who may apply for an expedited review and the circumstances in which it can be used. The application is made by, or on behalf of, the chief officer of police and must be made in the form which is set out in Schedule 8A to the Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 (SI 2005/42).

Protection of children from harm

- 2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.
- 9.12 Each responsible authority will be an expert in their respective field, and in some cases it is likely that a particular responsible authority will be the licensing authority's main source of advice in relation to a particular licensing objective. For example, the police have a key role in managing the night-time economy and should have good working relationships with those operating in their local area5. The police should usually therefore be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective. However, any responsible authority under the 2003 Act may make representations with regard to any of the licensing objectives if they have evidence to support such representations. Licensing authorities must therefore consider all relevant representations from responsible authorities carefully, even where the reason for a particular responsible authority's interest or expertise in the promotion of a particular objective may not be immediately apparent. However, it remains incumbent on all responsible authorities to ensure that their representations can withstand the scrutiny to which they would be subject at a hearing.

The Licensing Authority would also like to draw to the attention of the Licensing Committee Section 9.12 of the 2018 Guidance. This states that the police should be the licensing authority's main source of advice on matters relating to the promotion of the crime and disorder licensing objective. Given that Thames Valley Police are applying for this review should indicate the seriousness of the issues raised by the operation of the premises. This premises has demonstrated on the numerous occasions mentioned in the review paperwork that it is neither competently run or responsible. Therefore it poses a significant risk to the safety of its customers, the public at large including children and any kind of promotion of the licensing objectives.

Reading Borough Council Statement of Policy (2018)

1. Introduction

1.1 This policy sets out how the Council as the Licensing Authority for Reading promotes the four licensing objectives stated in the Licensing Act 2003. The four licensing objectives, as outlined in Section 4 (2) of the Licensing Act 2003, are of equal importance and the Council along with other named Responsible Authorities, stakeholders, residents and licence holders shall work together in order to actively promote them. Those four licensing

objectives are:

- The prevention of crime and disorder
- The prevention of public nuisance
- The protection of children from harm
- Public Safety
- 1.2 The Council must have regard to the four licensing objectives when carrying out it's functions under the Licensing Act 2003. The Licensing Authority will also have regard to other Council policies which have been introduced to tackle issues that may undermine crime and disorder or any of the other licensing objectives. The Licensing Authority will have regard to the contents of this policy as well as the Secretary of State's Guidance issued under Section 182 of the Licensing Act 2003. It may also depart from this policy and the Secretary of State's Guidance if there are exceptional circumstances and it is appropriate to do so to promote the licensing objectives. If the Licensing Authority departs from the Secretary of State's Guidance it will give reasons as per paragraph 1.9 of that guidance.
- 1.3 The legislation also supports other key aims and purposes. These are outlined in paragraph 1.5 of the guidance and should be principal aims for all parties involved in licensing for the promotion of the licensing objectives. The licensing authority will have regard to these key aims in it's decision making. They are:
- Protecting the public and local residents from crime, anti-social behaviour and noise nuisance associated and caused by irresponsible licensed premises;
- Giving the police and licensing authorities the powers they need to effectively manage and police the night time economy and take action against those premises that are causing problems;
- Recognising the important role which pubs and other licensed premises play in our local communities by minimising the regulatory burden on business, encouraging innovation and supporting responsible premises;
- Providing a regulatory framework for alcohol which reflects the needs of local communities and empowers local authorities to make and enforce decisions about the most appropriate licensing strategies for their local area;
- Encouraging greater community involvement in licensing decisions and giving local residents the opportunity to have their say regarding licensing decisions that may affect them.

Summary

Under the Licensing Act 2003 premises licence holders have a duty to be responsible, operate lawfully, adhere to the conditions on their licence and to take every step to promote the licensing objectives at all times, not just to seek to apply them once the responsible Authorities have applied for a review.

It appears to the Licensing Authority once the review papers had been served, that the premises licence holders are only now responding to the issues raised in this review, despite being told about several issues of non-compliance in January 2019. The Licensing Authority believe this is too little too late.

The Licensing Authority, together with the other responsible Authorities have a duty to promote the licensing objectives for the safety of the wider public and not in the interests of individual premises licence holders and therefore recommend that the Committee seriously consider revoking the Premises licence for Yates 7-9 Friar street, Reading RG1 1DB. However, if the Committee believe the Premises can operate lawfully and responsibly in the future, more robust conditions, a reduction in closing hours and a period of suspension to fully implement the conditions and to ensure management and staff are fully trained may be an alternative to revocation.

On the 24th January 2019 I visited your premises to ensure you are complying with the above premises licence and advise on any matters that may arise during the inspection. The inspection was carried out with the DPS Mr John Button.

During my inspection, I found a number of items that require your attention as outlined below:

- 1) The correct Part A of the licence could not be produced. The most up to date licence is numbered LP2002418 dated 14th January 2019. Please ensure the correct copy of Part A is kept securely on site.
- 2) Part B of the premises licence was not displayed. Part B needs to be displayed in a prominent position so that your customers can see that you are licensed. All pages of Part B should be displayed. Please ensure this is rectified.
- The Gaming machine permit for your three gaming machines could not be produced. Please ensure this is kept on site so that it can be produced to ourselves or the Gambling Commission if required.
- 4) Condition 2 on your licence in repsect of risk assessments for any special events could not be demonstrated as being complied with. No risk assessments could be produced. We also spoke about the requirement to risk assess some of your upcoming events and keep the risk assessment under review. Please ensure this is rectified.
- 5) Condition 7 on your licence in respect of a written drug prevention policy could not be demonstrated as being complied with. No policy could be produced. This policy should not be a generic policy and should be site specific. This is particularly important given the recent high levels of drugs that were found when the police swabbed areas of the premises. Please ensure this is rectified.

- 6) Condition 10 on your licence in respect of a written search policy could not be demonstrated as being complied with. No policy could be produced. Please ensure that any policy is site specific and that all of your staff including door staff are implementing it. Please ensure this is rectified.
- 7) Condition 12 on your licence in respect of a written entry, closure and dispersal policy could not be demonstrated as being complied with. No policy could be produced. Please ensure that the policy is site specific and incorporates everything the venue does including the actions taken by door staff at the end of the night when they put on the tabards to disperse people. Please ensure this is rectified.
- 8) Condition 14 on your licence in respect of displaying signs at the exits advising customers that open containers, glassware and bottles are not to be taken outside was not being complied with. No signs were in place. Please ensure that this is rectified and that customers are not standing on Friar Street with drinks or using it as a smoking area.
- 9) Condition 18 on your licence in respect of signs being put up to advise customers to leave quietly was not being complied with. No signs were in place. Please ensure this is rectified.
- 10) Condition 25/26 and 27 you are reminded that the smoking area/garden and balcony area are only to be used at the times stated within these conditions and that the garden area is to be used as a smoking area.

Please ensure all of the above is rectified within 28 days. Please notify me when the issues in this letter have been rectified so that I can arrange a re-inspection.

11. APPLICATION FOR THE REVIEW OF A CLUB PREMISES CERTIFICATE - YATES'S.

The Assistant Director of Planning, Transport and Regulatory Services submitted a report on an application by the Chief Constable of Thames Valley Police for the summary review of a Premises Licence for Yates's, 7-9 Friar Street, Reading, RG1 1DB.

The report stated that Thames Valley Police had requested a summary review because the premises had been associated with serious disorder. There had been two recent incidents of note. The first had taken place on 1 January 2020, following a fight within the venue which premises security had been unable to contain or deescalate. This had resulted in police having to enter the premises and later 20 police officers had needed to form a police line to disperse the crowd when the venue was closed. The second incident had taken place three days later and had again required the formation of a police line to assist with the dispersal of a crowd of approximately 150 people. Thames Valley Police had submitted a Certificate under Section 53A (1)(b) of the Licensing Act 2003, which stated that the summary review was necessary to uphold the licensing objectives of the prevention of crime and disorder, protection of children from harm and public safety.

A copy of the summary review application and appendices was attached to the report at Appendix RS-I.

The report stated that the Premises Licence Holder was Stonegate Pub Company Limited and the Designated Premises Supervisor was Mr John Button. The existing Premises Licence, a copy of which was attached to the report at Appendix RS-2, permitted the following:

- The prevention of public nuisance;
- The protection of children from harm.

The report further stated that, in determining the application, the Sub-Committee could take the following interim steps:

- The modification of the conditions of the premises licence;
- The exclusion of the sale of alcohol by retail from the scope of the licence;
- The removal of the Designated premises Supervisor from the licence;
- The suspension of the licence.

Any interim steps would take effect immediately and stay in force until the determination of the review. The review hearing must be held within 28 days of the application and had been arranged for 31 January 2020.

The report set out paragraphs 1.5, 12.1, 12.2, 12.5, 12.6, 12.13, 12.14, 12.15, 9.12, 11.10, 11.12, 11.18, 11.24 to 11.28 from the Secretary of State's Guidance to the Licensing Act 2003 issued in April 2018. The report also set out paragraphs 5.13 and 5.15 of the Council's Statement of Licensing Policy.

Simon Wheeler, Thames Valley Police, was present at the meeting and addressed the Sub-Committee on the review application. He was accompanied by Declan Smyth and officers Nara Fisher and Jason Jones of Thames Valley Police

Mr Michael Bromley-Martin, QC, was present at the meeting as representative of Stonegate Pub Company Limited. He was accompanied by Mr Paul Wright, Director of Operational Licensing, Stonegate Pub Company Limited and Mr Graeme Cushion, solicitor, Poppleston Allen.

Robert Smalley, Licensing and Enforcement Officer, presented the summary review report at the meeting.

Resolved -

- (1) That, having regard to the four licensing objectives and the oral and written representations made, the Secretary of State's guidance issued under section 182 of the Licensing Act 2003 (April 2018), the Council's Statement of Licensing Policy, the Sub-Committee concluded that it was appropriate and proportionate to suspend the Premises Licence in respect of Yates's, 7-9 Friar Street, until the determination of the application for review, as the Sub-Committee considered that the two incidents on 1 and 4 January 2020 were so serious that a period of immediate suspension was necessary.
- (2) That Stonegate Pub Company Limited was requested to ensure that sufficient and adequate cancellation of pre-booked events be advertised widely and on social media platforms.

The meeting opened at 10.00 am and closed at 12.00pm.
