1. EXECUTIVE SUMMARY

- 1.1 This report sets out the decision to use the latest round of Household Support Funding to support vulnerable families and individuals from 1 April 2022 to 30 September 2022. The funding amount allocated to the Council by the Department for Work and Pensions is £1,130,648.94. The fund must be spent or committed to by 30 September 2022.
- 1.2 In summary, the Grant Conditions are to provide support to households who would otherwise struggle to buy food or pay essential utility bills or meet other essential living costs or housing costs (in cases of genuine emergency) due to significantly rising living costs.
- 1.3 This funding round places a greater emphasis on supporting households with energy bills. Food and water bills also remain priorities. Additionally, at least one third of the total funding must be spent on families with children and at least one third must be spent on people receiving the state pension.
- 1.4 The previous Decision Book (issue 658) laid out initial proposals for this funding. This report provides proposals for use of the remaining funding (approx. £290,000) as set out in section 4.
- 1.5 The following nine Decision Books have been completed relating to previous Household Support Funding:

2.0 DECISION

- 2.1 It is the decision of the Chief Executive, in consultation with the Leader of the Council that the remaining Household Support Fund extension funding will be allocated as follows:
- (a) Reading voluntary and community sector (VCS) organisations to support Reading residents with ongoing food, warmth and living costs, as laid out in section 4 of this report
- (b) A targeted Energy Voucher Scheme for families with school age children eligible for Pupil Premium Free School Meals, vulnerable children up to nursery age and care leavers (1 x £49 voucher per family/care leaver)

3. BACKGROUND

- 3.1 The DWP (Department of Work and Pensions) have over the past two years provided several rounds of grant funding related to provision of food and energy support. The details of these can be found in the previous nine decision books.
- 3.2 The DWP have revised the funding criteria for the latest funding round. At least one third of the total funding must be spent on families with children and at least one third must be spent on people receiving the state pension. In terms of type of support, the expectation is that the HSF extension should be used in a similar way as the original HSF scheme, although, with a greater emphasis on supporting households with energy bills. Food and water bills also remain priorities.

4. PHASE 2 PROPOSALS

- 4.1 Approximately £290,000 of funding is likely to be available from the original funding allocation. The exact total will be confirmed after 30 September 2022 once the energy voucher scheme has closed and any underspends have been calculated.
- 4.2 Consultation across services and directorates has taken place in order to identify key priorities for the remaining funding (within the parameters of the grant conditions) that are simple to administer and quick to distribute.
- 4.3 An additional £49 Energy Voucher will be provided to the same families / care leavers who have been provided with an initial £49 voucher earlier in this funding round those with school age children eligible for Pupil Premium Free School Meals / vulnerable children up to nursery age (1 x £49 voucher per family) and approximately 140 care leavers (1 x £49 voucher per care leaver). Maximum spend

= £197,000.

- Winter clothing and warmth support (including for carers, people with disabilities and the homeless) (£10,000) The Cowshed
- Winter clothing and food support for refugees (£5,000) Reading Refugee Support Group

5. APPEALS

5.1 Discretionary Support Schemes are not subject to any formal statutory appeals process and therefore there are no appeal rights.

6. FRAUD

- 6.1 The Council will not accept deliberate manipulation and fraud and any resident caught falsifying their records to gain support will face prosecution and any payment issued will be subject to claw back, as will any payments paid in error.
- 6.2 One of the biggest risks for this scheme is impersonation fraud, where fraudsters work through a residential area and falsely claim under the names of eligible recipients. Risk has been reduced by a targeted scheme to eligible families/individuals.
- 6.3 The DWP advise that Authorities wishing to work with Third Party Organisations to deliver the scheme must carry out suitable due diligence checks to ensure they are viable and able to deliver the support. So, for example, ensuring all charities are registered and taking extra caution if they are new organisations.
- 6.4 Authorities are also encouraged to ensure checks are in place to verify the identity of those eligible.

7. CONTRIBUTION TO STRATEGIC AIMS

- 7.1 This proposal will contribute to the following key priority set out in the Council's Corporate Plan 2021 2022
 - Thriving Communities: by ensuring the most economically disadvantaged

families and children receive Government funding to tackle the impacts of the pandemic

9.1 Communications appropriate to a targeted scheme will be sent to all those eligible to benefit from the scheme. Schools and our key VCS partners will also promote take up of the scheme and general communications will be provided on our website. There will be minimal social media promotion to mitigate any potential risks of fraudulent claims.

12. FINANCIAL IMPLICATIONS

- 12.1 The cost of these payments will be met by Central Government the Household Support Scheme is ring-fenced funding.
- 12.2 The Household Support Scheme funding allocation <u>includes</u> reasonable administration costs to enable Authorities to deliver the scheme. Authorities should deduct their estimated administration costs from the total allocation to determine the amount remaining. In all cases, Authorities should keep administrative costs to a reasonable level. Administration costs for each Authority will be published on www.gov.uk alongside detail of all spend related to this scheme.
- 12.3 Reading Council will claim 5% admin costs to fund the administration of the scheme (including for Post Office Payout vouchers) and BFfC admin costs.
