1. Title of decision:	To enter a works contract with HP Contracts Ltd to refurbish 35 Alexandra Road for RBC Children's Homes.

4. Decision details:

- a) To seek approval to appoint HP Contracts Ltd to carry out refurbishment works to 35 Alexandra Road for the use of a Children's Home.
- b) To provide an update on the now concluded compliant procurement and evaluation process.

5. Reasons for the decision:

- a) Procurement under the 2015 Public Contract Regulations has been concluded.
- b) Quality (Technical) and Price (Commercial) evaluation have been concluded and moderated by the procurement team.
- c) The market has offered costs that are within our existing budget, and a programme that suggests completion by the end of this financial year, ready for Children's Services to use this from the start of the new financial year.
- d) We have procured this through the Westworks DPS to give us confidence that all contractors have the skills and experience to carry out the works required.
- e) This decision is required to enable us to inform the contractors of our intentions to appoint them as soon as internal governance approvals are concluded.

6. Alternative options considered (if any) and rejected:

- The option to continue housing children out of borough was rejected.
- Tenders were received from 9 contractors, some of whom priced for all three and some for two.
- All submissions were considered and clarifications sought and reviewed.
- One contractor withdrew their submission, and one other was found to be non-compliant.
