

## **Premise: AFTER DARK, READING**

### **Timeline of Events**

30<sup>th</sup> August 2017 – License Transfer into the name of the current premises license holder.

12<sup>th</sup> January 2018 – Received complaints from residents regarding noise coming from within the club & groups of people gathering on the streets outside.

27<sup>th</sup> February 2018 – Licensing inspection – Poor Response at Premises after concerns over under age events. Poor Policies and Procedures recorded.

5<sup>th</sup> March 2018 – Follow up to licensing inspection undertaken by Declan SMYTH.

9<sup>th</sup> March 2018 – Confirmation received that the site still does not have CCTV within the venue. It was confirmed that the premises would not be open to the public until this issue had been rectified.

29<sup>th</sup> March 2018 – Drug swabbing of premise undertaken and a high reading for cocaine to the level of 5.34 was recorded within the ladies toilets.

13<sup>th</sup> October 2018 – Assault took place within the venue whereby a male was punched.

21<sup>st</sup> October 2018 – Email received from Zahid KHAN requesting information on a booking for a London artist relating to an event that was due to take place on 26/10/18.

22<sup>nd</sup> October 2018 – Thames Valley Police were made aware that the booking KHAN was referencing involved a cancelled booking from another venue due to incidents of assault and disorder relating to the promoter/artist.

23<sup>rd</sup> October 2018 – Email received from KHAN confirming that he would not be booking the high risk event for 26/10/2018. TVP emailed KHAN acknowledging the cancellation of the event and informing him that although we supported his decision, the decision for the cancellation was KHAN's and not TVP's.

23<sup>rd</sup> October 2018 – Thames Valley Police objected to a TENS involving an underage event due to run on the 30/10/2018.

22<sup>nd</sup> November 2018 – Email received from KHAN stating that the After Dark would no longer be booking any events with the high risk promoter. Within the email KHAN states that he has heard about a high risk promoter whilst compiling his risk assessments for two recent events and due to the evidence that he has compiled has decided not to carry out events that endanger the future of his club by endangering patrons or being a nuisance to members of the public.

1<sup>st</sup> December 2018 – Urban music event took place at premises involving a large fight that was instigated by persons on a current Pub Watch ban that had been allowed within the premises. Dispersal issues occurred outside of the premises requiring extensive police resourcing. GEN 40 received from PC BALMFORTH identifying issues with a disorderly dispersal of patrons outside the AFTER DARK

CLUB after having been informed that a fight had taken place within the venue resulting in the management shutting the venue.

29<sup>th</sup> January 2019 – Email received from KHAN cancelling a high risk event that he had booked for 01/02/2019 involving a high risk promoter.

To whom it may concern

I PC 5787 Simon Wheeler on behalf of the Chief Officer of Thames Valley Police wish to object to the current late TEN application under section 104(2) Licensing Act 2003, regarding The After Dark Club (see attached application).

Thames Valley Police are satisfied that the premises when used in conjunction with this Temporary Events notice shall undermine the licensing objectives and with specific regard for the prevention of crime and disorder and the protection of children from harm.

The rationale for our decision in this matter is as follows:-

- 1) The application contains many undertakings in relation to the collation of information from students, yet no documentary evidence has been produced to support this.
- 2) The detail contained within the application is vague in that no details of the school itself have been provided, and or of any adult organisers directly linked to the school named.
- 3) Due to the TEN being submitted late there are no official checks which can be made with the school (if identified) to confirm that this is an official event run by teachers etc and with responsible adults ensuring child safety.
- 4) Previous information from responsible authorities has suggested that potentially events of this nature that have been run before under a TEN and with the same undertakings given, may not have been compliant with such undertakings.

The current secretary of state's section 182 guidance states;

- 7.32 The system of permitted temporary activities gives police and EHAs the opportunity to consider whether they should object to a TEN on the basis of any of the licensing objectives.
- 7.33 **If the police or EHA believe that allowing the premises to be used in accordance with the TEN will undermine the licensing objectives, they must give the premises user and the licensing authority an objection notice.** The objection notice must be given within the period of three working days following the day on which they received the TEN.
- 7.34 Where a standard TEN was given, the licensing authority must consider the objection at a hearing before a counter notice can be issued. At the hearing, the police, EHA and the

premises user may make representations to the licensing authority. Following the hearing, the licensing authority may decide to impose conditions which already apply to an existing premises licence or club premises certificate at the venue, or issue a counter notice to prevent the event going ahead. **As noted above, there is no scope for hearings in respect of late TENS and if objections are raised by the police or EHA in relation to a late TEN, the notice will be invalid and the event will not go ahead.**

Therefore in relation to this application for a late TENS Thames Valley Police are satisfied that our concerns in relation to this event are sufficient to believe that the licensing objectives shall be undermined in relation to the protection of children from harm and the prevention of crime and disorder.

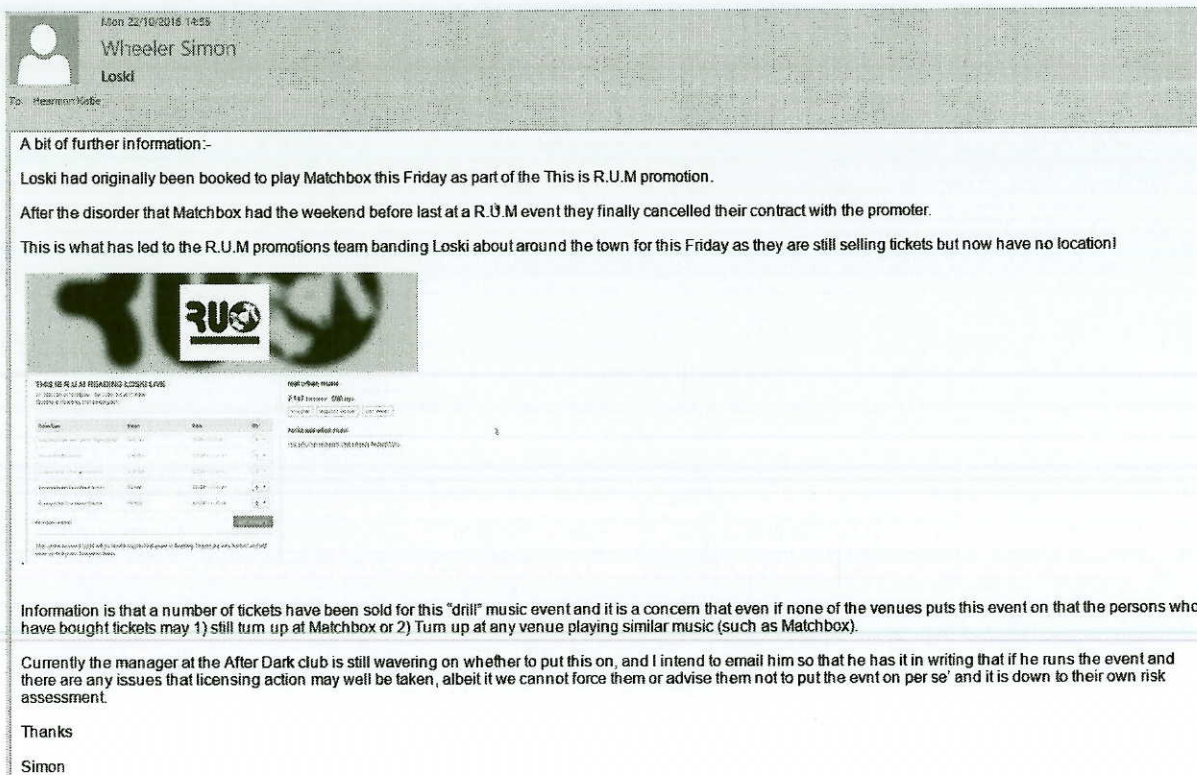
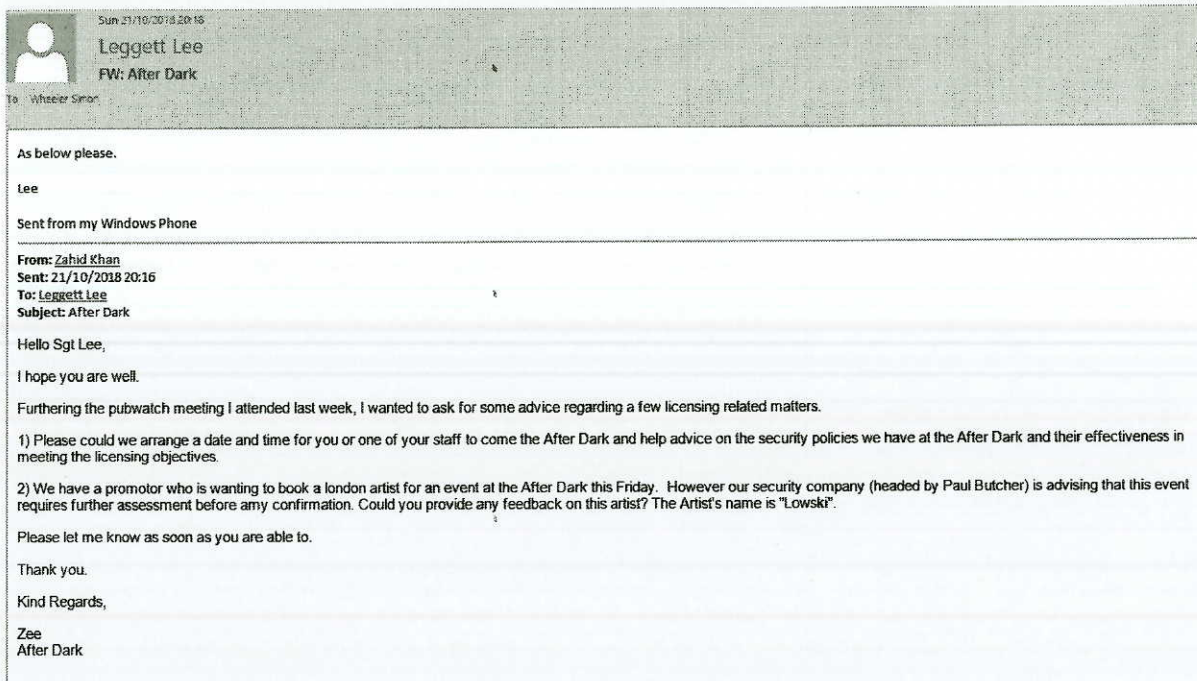

Furthering our conversation last week, I wanted to confirm that the After Dark will not be booking any events with the This is Rum group in the foreseeable future.

I was initially really keen to find a way to have a more "modern event" at the After Dark. Unfortunately the feedback I have heard about This is Rum outfit in compiling the risk assessments for the 2 recent events from a variety of people is quite worrying. For that reason we did not and will not carry out events which endanger the future of this club by endangering people or being a nuisance to the public.

Most of the After Dark events are internal as we have a regular and loyal customer base. We do use external promoters occasionally. For example for the next 3 months we currently have 2 x booked in by an external promoters who have been customers of the club for years and have already held proven events.

I know you don't know me that well but I hope I have given a good impression of our club in our occasional and brief discussions. The After Dark site has been entertaining people since 1950, especially with live music. The club has been owned by my family for 20 years and I was the licence holder in 2003. I am passionate about making this place successful by being more open and relevant in Reading than it currently is, and bringing all our current customers with us.

We are not trying to do "risky" events by assessing promoters, or holding specific TENs. We are looking to manage risk through actual action and not an automatic process. Especially with more diverse events we feel we can lay seeds for the future for this club to be here and successful for another 68 years. We are not expecting favours, but we do need understanding, patience, discussion, support and feedback from the police and the council to do this by helping us manage risk.

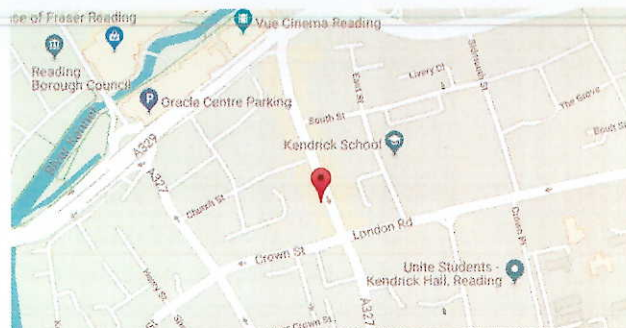
